## **PROCLAMATION**

## **RE: SHELLFISH POLLUTED AREA**

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Dr. Lawrence Greenblatt, State Health Director, Department of Health and Human Services, hereby announces that the following shellfish area temporary closures will <u>take effect immediately</u>.

It is unlawful for any person to take or attempt to take any oysters, clams or mussels or possess, sell or offer for sale any oysters, clams or mussels taken from the following polluted areas:

## BRUNSWICK / PENDER / ONSLOW / CARTERET COUNTIES

<u>All those waters</u> bordered on the east by a line beginning at a point 33° 54.2904′ N - 78° 23.6416′ W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932′ N - 78° 23.6426′ W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the South Carolina State Line, to include Tubbs Inlet.

<u>Lockwoods Folly River - All those waters</u> north of a line beginning at a point 33° 55.5678′ N - 78° 13.8043′ W on the south shore of Spring Creek near the mouth; running easterly to a point 33° 55.4621′N - 78° 13.1714′ W near the northern tip of Sheep Island; thence running southeasterly to a point 33° 55.2284′N - 78° 12.7791′ W near the northwest point of Horse Island, to include a portion of the Intracoastal Waterway north of Horse and Sheep Islands.

<u>All those waters</u> bordered on the north by a line beginning at a point 34° 33.0934′ N - 77° 21.6926′ W on the mainland near Hatch Point, running easterly near Marker "76" to New River Inlet Channel Beacon "12", thence running southerly following the dredged channel to the eastern tip of North Topsail Beach at New River Inlet; and bordered on the south by the Surf City Bridge, to include Stump Sound, Alligator Bay, and Chadwick Bay.

<u>All those waters</u> in Queens Creek upstream of a straight line across the mouth, beginning at a point 34° 39.8479'N - 77° 09.1171' W on the west shore; running northeasterly to a point 34° 40.2031'N - 77° 08.4408' W on the east shore near the State Park Boat Ramp.

All those waters in White Oak River upstream of the Highway 24 Bridge at Swansboro.

<u>All those waters from the Intracoastal Waterway to the mainland</u> in Bogue Sound between the permanent closure line near 16<sup>th</sup> St. in Morehead City and IWW Marker "17", to include the Intracoastal Waterway.

<u>Newport River - All those waters</u> in Newport River upstream of the Highway 70 High Rise Bridge and the Morehead-Beaufort Causeway, to include all tributaries and Core Creek.

All those waters bordered in the east by a line beginning at a point 34° 54.2203' N -76° 18.8592' W near Hall Point, running southeasterly to Beacon "20"; thence running southwesterly to Beacon "33" in Core Sound; thence running southwesterly to Green Marker "37" off Jarrett Bay; thence running southwesterly to Shell Point on Harkers Island; and bordered in the west by a line beginning at a point along the southwestern tip of Harkers Island at 34° 42.0981' N - 76° 35.0718' W; running in a straight line to the permanent closure line near Beacon "5", to include North River, Ward Creek, Whitehurst Creek, Sleepy Creek, Straits, Westmouth Bay, Jarrett Bay, Oyster Creek, Brett Bay, Nelson Bay, and a portion of Core Sound.

<u>All those waters</u> bounded in the north and east be a line beginning at a point 34° 59.1474' N - 76° 16.3156' W on Hog Island, running southeasterly to a point 34° 58.9645' N - 76° 16.1410' W; thence following the shoreline to Hog Island Point; thence running southwesterly to Long Point, thence running southwesterly to Lookout Point; thence running southwesterly to Hall Point, to include Thorofare Bay, Rumley Bay, Lewis Creek, and Cedar Island Bay.

<u>All those waters in South River</u> upstream of a line beginning at Sandy Point; running easterly near Beacon "1" to Horton Point.

## **GENERAL INFORMATION:**

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. These temporary closures are due to heavy rainfall and resultant runoff.
