PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Michael S. Loeffler, Interim Director, Division of Marine Fisheries, upon the recommendation of Dr. Lawrence Greenblatt, State Health Director, Department of Health and Human Services, hereby announces that the following shellfish area temporary **closures will take effect immediately**.

It is unlawful for any person to take or attempt to take any oysters, clams, or mussels or possess, sell, or offer for sale any oysters, clams, or mussels taken from the following polluted areas:

NEW HANOVER COUNTY

All those waters from the Intracoastal Waterway to the mainland between IWW Marker "141" (34° 07.7515'N - 77° 51.9560' W) near Peden Point and IWW Marker "155" (34° 04.8189'N - 77° 52.9654' W) near Carolina Beach Inlet, to include the Intracoastal Waterway.

All those waters in Masonboro Sound and Middle Sound bordered on the north by the Figure Eight Island Bridge; and bordered on the south by a line beginning at a point 34° 07.7706'N - 77° 52.0833' W on the mainland near Peden Point; running easterly near IWW Marker "141" to a point 34° 07.6007'N - 77° 51.0328' W on Masonboro Island.

The following also remains closed:

BRUNSWICK / NEW HANOVER / PENDER / ONSLOW / CARTERET COUNTIES

All those waters bordered on the east by a line beginning at a point 33° 54.2904' N - 78° 23.6416' W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932' N - 78° 23.6426' W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the South Carolina State Line, to include Tubbs Inlet.

All those waters from the Intracoastal Waterway to the mainland between IWW Marker "105" (34° 19.4274'N - 77° 42.9507' W) near Green Channel and the Figure Eight Island Bridge, to include the Intracoastal Waterway.

All those waters bordered on the north by a line beginning at a point 34° 33.0934' N - 77° 21.6926' W on the mainland near Hatch Point, running easterly near Marker "76" to New River Inlet Channel Beacon "12", thence running southerly following the dredged channel to the eastern tip of North Topsail Beach at New River Inlet; and bordered on the south by a line beginning at a point 34° 31.1227' N - 77° 22.3142' W on the mainland, running southerly near Beacon "15" to a point 34° 31.0527' N - 77° 22.2654' W on North Topsail Beach, to include Chadwick Bay.

All those waters from the Intracoastal Waterway to the mainland between the Emerald Isle High Rise Bridge and IWW Beacon "65A" (34° 32.7006'N - 77° 19.0487' W), to include the Intracoastal Waterway, Salliers Bay, Freeman Creek, Bear Creek, Queens Creek, and White Oak River.

All those waters in Bogue Sound bordered on the east by a line beginning at a point 34° 42.5733' N - 76° 57.3713' W on the mainland, running southerly near IWW Beacon "29" and the eastern tip of Wood Island to a point on Emerald Isle at 34° 40.7397' N - 76° 56.8821' W; and bordered on the west by the Emerald Isle High Rise Bridge, to include Deer Creek, Hunting Island Bay, Goose Creek, and Sanders Creek.

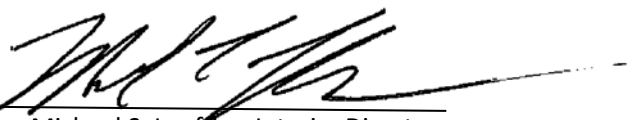
Newport River - All those waters in Newport River upstream of the Highway 70 High Rise Bridge and the Morehead-Beaufort Causeway, to include all tributaries and Core Creek.

North River - All those waters in North River upstream of a straight line beginning at a point 34° 44.4581' N - 76° 37.3826' W on the shore south of Cow Pen Creek; running easterly near the old Fl. "Danger" Beacon to a point 34° 44.4929' N - 76° 35.3320' W on the northwest shore of Goose Bay, to include all of Ward Creek.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.C. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under their delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. These temporary closures are due to heavy rainfall and resultant runoff.
