Question 1: How can I find the Mitchell Will Index?

1. Go to <https://archives.ncdcr.gov/doc/search-doc>
2. Click on the link for “Show advanced search options”




Figure 1 - A screenshot of DOC's basic search screen with a red circle around “Show advanced search option.”

3. Type “Mitchell Will Index” into the Title search field.
4. Click the search button or press enter.
5. The Mitchell Will Index will be the only result.
