
NC Cardinal Users Annual Meeting

LSTA Grants Announced

On June 6, N.C. Department of Natural and Cultural Resources Secretary Susi H. Hamilton announced more than \$2 million in 2019-20 Library Services and Technology Act (LSTA) grants for local N.C. libraries at an event held at UNC-Wilmington's Randall Library.

LSTA grants are distributed through the State Library in response to specific needs of public, academic, and community college libraries. These federal funds are investments that help libraries deliver relevant and up-to-date services to their communities. This year's grants include 43 awards for local library projects that strengthen capacity, expand access and engage communities.

Library Development (LD)

Supports libraries throughout the state, through innovative programs and services, to help them meet the needs of their communities.

Library for the Blind & Physically Handicapped (LBPH)

Serves blind and physically handicapped readers, through a wide range of books and magazines in print, braille, and audio formats.
