Ladies and Gentlemen:

Across North Carolina, the North Carolina Office of the State Auditor (OSA) identified 688 landfill sites where municipal solid waste disposal occurred without regulatory oversight prior to January 1, 1983. Of the 688 pre-regulatory landfill sites, 84% are within 1,000 feet of homes, schools, daycares, churches, or drinking water wells.

The North Carolina Department of Environmental Quality, a cabinet agency of the Office of the Governor, is charged with identifying, assessing, and remediating these sites through its Division of Waste Management, Pre-Regulatory Landfill Program. OSA audited this program, and found that, since creation of the program in 2007, 534 of the 688 sites have never been investigated.

These sites may contain hazardous, medical, or asbestos-containing materials, as well as elevated levels of landfill gases such as methane. In addition, there may be contamination of groundwater, surface water, soil, and sediment, all of which can pose significant risks to public health and the environment. But because the sites have not been investigated and gone through the full extent of the Pre-Regulatory Landfill Program, there is no confirmation of the contamination levels, the potential spread of contamination, and whether there is risk to nearby residents.

Further complicating matters are site location and remediation costs. Approximately 78% of the sites identified are privately owned. OSA's audit also shows that it costs an estimated \$1.9 million on average to investigate, assess, and remediate a site. Should this cost be applied across the remaining 534 unmonitored sites, full remediation could approach \$1 billion.

The Department of Environmental Quality's Division of Waste Management has agreed with the findings and OSA's recommendations in this audit. For full transparency, the State Auditor's Office has included in the appendices all landfill sites, including risk priority listing, sites pending access permission, and sites that have been addressed.

The North Carolina Office of the State Auditor (OSA) conducted a performance audit of the North Carolina Department of Environmental Quality (DEQ), Division of Waste Management (DWM), Pre-Regulatory Landfill Program (Program) to determine whether the Program monitored inactive hazardous substance or waste disposal sites in accordance with State law, DWM policies and procedures, and best practices.

Background

The Program was established in 2007 to identify, assess, and remediate sites that accepted a wide range of waste types without regulatory oversight prior to January 1, 1983. These sites include publicly or privately owned properties where municipal solid waste disposal occurred prior to January 1, 1983, but not thereafter.¹ These former landfills may contain hazardous, medical, or asbestos-containing materials, as well as elevated levels of landfill gases such as methane. In addition, there may be contamination of groundwater, surface water, soil, and sediment, all of which can pose significant risks to public health and the environment.

The Program operates under the DWM within DEQ. State law requires DEQ to develop a program for “locating, cataloguing, and monitoring all inactive hazardous substance or waste disposal sites in North Carolina.”² As of June 30, 2025, the Program had an inventory of 688 sites.

What We Found

As of June 30, 2025, 534 of North Carolina’s 688 identified pre-regulatory landfill sites (78% of the total inventory) had never been investigated. For most of those sites, the State does not yet know what contamination may be present, whether it has spread to nearby properties or water supplies, or whether current conditions pose a risk to nearby residents.

Most of the unmonitored sites are within 1,000 feet of homes, schools, daycares, churches, or drinking water wells. Where investigations have occurred, serious hazards have been found. For example, 23 of 97 sites that reached the investigation stage (24%) had methane concentrations exceeding the lower explosive limit of 5%.

In the three case studies auditors examined, none of the hazards were detected through Program-initiated monitoring; all hazards were revealed by outside events.

At current funding levels, remediating each of the unmonitored sites would take approximately 99 years. If many of the remaining sites require work at the Program’s historical average cost, the gross scale approaches \$1 billion.³

Recommendations

To help DEQ fulfill its responsibilities, OSA recommends that DWM:

- **Address resource constraints** to maximize the impact of existing Program resources by reevaluating how sites are prioritized and advanced through investigation and remediation, while also pursuing additional funding sources and opportunities to strengthen program capacity and accelerate progress.
- **Strengthen mechanisms to obtain access to high-risk sites** by working with the General Assembly and internal legal counsel to allow the Program to obtain access to privately owned sites in extreme cases.

DWM should begin implementing administrative elements of these recommendations immediately. Recommendations requiring legislative action should be presented to the General Assembly within six months.

Chapter 147, Article 5A of the North Carolina General Statutes gives the Auditor broad powers to examine all books, records, files, papers, documents, and financial affairs of every state agency and any organization that receives public funding. The Auditor also has the power to summon people to produce records and to answer questions under oath.



Background

Monitoring Former Landfills

The Pre-Regulatory Landfill Program (Program) is responsible for monitoring former landfill sites that operated before modern environmental regulations took effect. Many of these sites are located near homes, schools, parks, and drinking water sources and may contain hazardous substances that pose ongoing risks to public health and the environment.

These sites include publicly or privately owned properties where municipal solid waste disposal occurred.⁴ These former landfills may contain hazardous, medical, or asbestos-containing materials, as well as elevated levels of landfill gases such as methane. In addition, there may be contamination of groundwater, surface water, soil, and sediment, all of which can pose significant risks to public health and the environment.

Pre-Regulatory Landfill Program

The Program was established in 2007 to identify, assess, and remediate sites that accepted a wide range of waste types without regulatory oversight prior to January 1, 1983, but not thereafter.

State law requires the North Carolina Department of Environmental Quality (DEQ) to develop and implement a program for “locating, cataloguing, and monitoring all inactive hazardous substance or waste disposal sites in North Carolina.”⁵ N.C.G.S. § 130A-310.6 specifically directs DEQ to assess, prioritize, and remediate pre-1983 landfill sites in priority order, subject to available funding.⁶ These provisions establish a clear statutory purpose but do not address how quickly progress must occur given funding limitations.

The Program operates under the Division of Waste Management (DWM) within DEQ. The primary mission of DWM is to safeguard public health and the environment by ensuring proper management of solid and hazardous waste, while effectively addressing existing contamination.

How the Program Works

Each site in the Program is treated as an individual project and is expected to move through four phases including site prioritization, investigation of the site, and the appropriate risk-based remediation. Upon discovery or entry into the Program, sites undergo an initial review of historical landfill use and surrounding land use. Based on this information, sites are scored and ranked using a risk-based prioritization process. Factors considered include landfill size, proximity to potable wells, and nearby land uses such as residences, schools, daycares, and churches.

In February 2024, the Program initiated a comprehensive potable well project. As of June 30, 2025, Phase I of this project involved identifying the number of potable wells located within a 1,000-foot radius of Program landfill sites, while Phase II of this project entailed distributing correspondence to property owners offering complimentary sampling for VOCs and PFAS analysis.⁷ The number of potable wells is a key attribute in determining risk rankings assigned to landfill sites, which will be updated based on the findings from these analyses.

Program Inventory and Scale

As of June 30, 2025, the Program had an inventory of 688 sites distributed across North Carolina. Program staff oversee site progression and contractor work, while environmental investigations and remediation activities are primarily conducted by third-party contractors. The Program maintains a public website listing known sites and their status.⁸

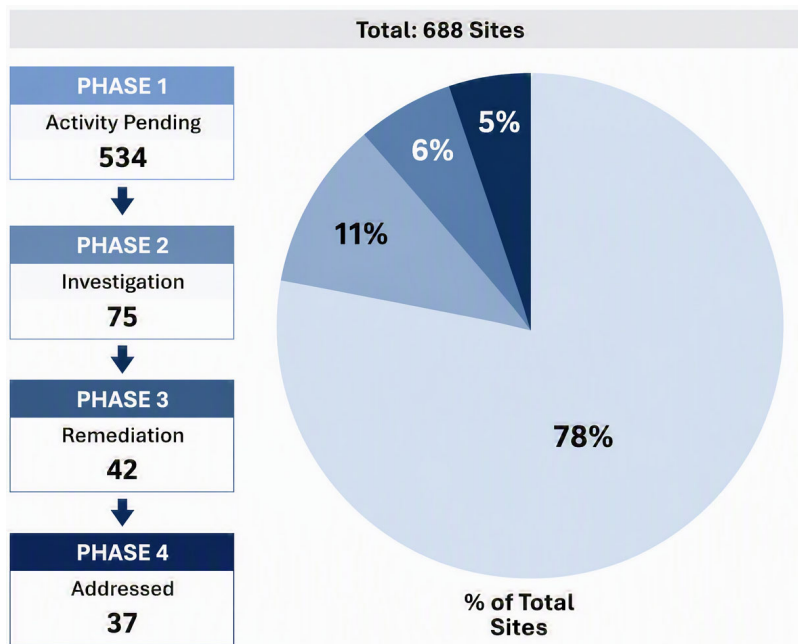

Site Statuses

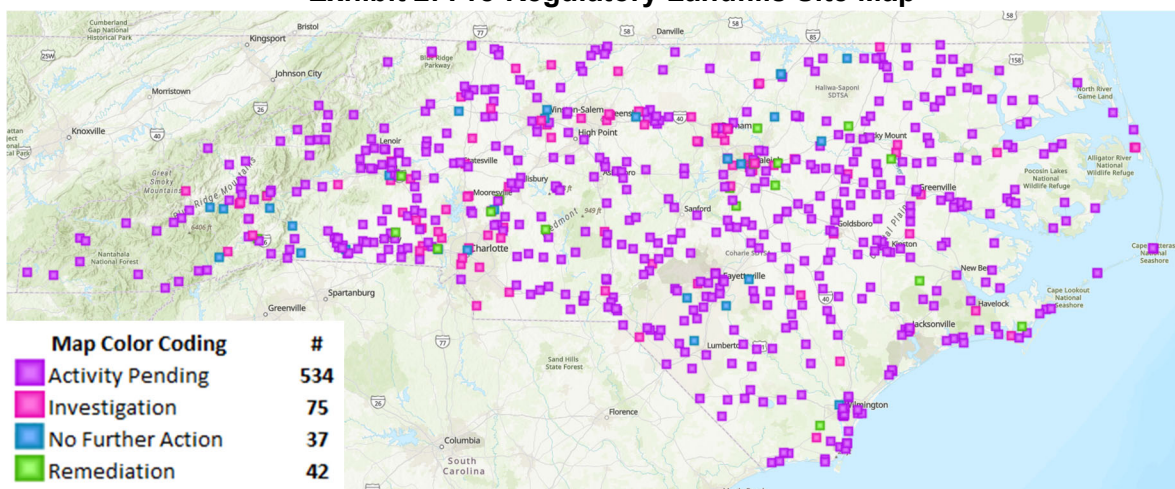
The Program assigns each site to one of four primary statuses, each representing a phase in the site remediation process. While all sites are catalogued, only some statuses involve active monitoring. Exhibit 1 shows the total number of sites in each phase as of June 30, 2025, and Exhibit 2 shows an example of the site map publicly available at DEQ's website.

Phase 1 – Activity Pending:

Activity Pending sites are awaiting investigation and are not actively monitored.

For these sites, the Program has not conducted environmental sampling or routine monitoring to determine whether contamination is present or worsening. Once a site enters the Program, it is assessed and assigned a risk priority score, which is based on historical information and surrounding land use and may not reflect current conditions. (See Appendix A for the risk priority score for all sites in the Program with a score as of April 2025. See Appendix B for a listing of all sites by County.)

Phase 2 – Investigation:

Sites advance to Investigation status when selected for further assessment.

During the Investigation phase, contractors seek property access, conduct site visits, collect samples, and prepare reports describing the extent of contamination and required waste disposal. Monitoring begins during this phase; however, investigations cannot proceed without property owner permission, which can delay or prevent site advancement. Of the 75 sites in investigation status, 18 had at least one property owner who did not grant access. (See Appendix C for sites pending access permission.)

If a local government desires to complete the investigation phase, they can hire a consulting firm to conduct these activities and request reimbursement from DEQ. The Program will still review work plans and cost proposals to verify the work activities are in accordance with the guidance document, and the Program's consent of the work plan confirms the work is eligible for reimbursement. Currently, eight sites are led by local governments.

Phase 3 – Remediation:

Once Investigation is complete, sites may enter the Remediation phase.

During the Remediation phase, contractors design and implement cleanup activities based on a risk-based approach. Monitoring during Remediation supports development, public review, and implementation of the remedial action plan (RAP). Remediation may also require property owners to record Notices of Environmental Contamination (NoECs)⁹ or Land Use Restrictions (LURs), which can delay or limit progress if owners decline to participate.

Phase 4 – No Further Action (NFA):

Once the RAP is completed and all impacted parcels of the site have LURs and a Notice of Environmental Contamination recorded, the site transitions to the NFA status.¹⁰ (See Appendix D for a listing of sites in NFA status.)

At this phase, the site is considered remediated to the level required by the Program, meaning the risks from contamination have been controlled through cleanup activities or other protective measures (such as soil caps). While this does not always mean contaminants have been completely removed, it does mean they are managed to an acceptable risk level. The Program does not require additional monitoring during this phase, but property owners must annually certify that LURs remain in place and site conditions are unchanged.

What the Program Has Accomplished

Since inception of the Program in 2007:

- **370 acres** of waste have been secured. This includes sites that were remediated or did not require remediation after investigation.
- **1,642 water supply wells** have been sampled. These water supply wells were sampled to assess the extent of contamination in and around investigated sites.
- **30 homes** have been provided with alternate water supplies. This includes connections to public water or installation of filtration systems, where needed.
- **\$1.9 million** has been spent, on average, per site remediation. This includes both investigation and remediation costs.

These results reflect meaningful progress and a clear public benefit. However, achieving these outcomes requires substantial and sustained Program funding.

⁹ A NoEC can be filed with the county deeds office and includes details about the type, location, and quantity of hazardous substances found on the site. If filed with a RAP, it becomes an LUR, which includes any DEQ-approved restrictions on current or future site use. Program Funding and Capacity

The Program's establishing legislation imposed a statewide solid waste disposal tax of \$2 per ton on waste disposed at permitted landfills.¹¹ Fifty percent of the disposal tax is deposited into the Inactive Hazardous Sites Cleanup Fund (Fund).¹² Average annual receipts for the Fund have ranged from approximately \$8.0 to \$12.7 million since the Program's inception in 2007. (See Appendix E for the Program's annual receipts and disbursements since inception.)

During the fiscal year (FY) ended June 30, 2025, the Program received \$12.7 million and spent \$14.5 million. As of June 30, 2025, the Program reported a fund balance of \$22.1 million, of which approximately \$16.3 million was committed for approved task orders that had not yet been paid. As shown in Exhibit 3, the Program had \$5.8 million in available cash after accounting for these approved but unpaid amounts.

State statute limits administrative expenses to a maximum of 19% of funds received.¹³ In SFY 2025, administrative expenses (personal services, supplies, and other expenses) represented approximately 15.5% of cash receipts, remaining below the statutory limit of 19%.

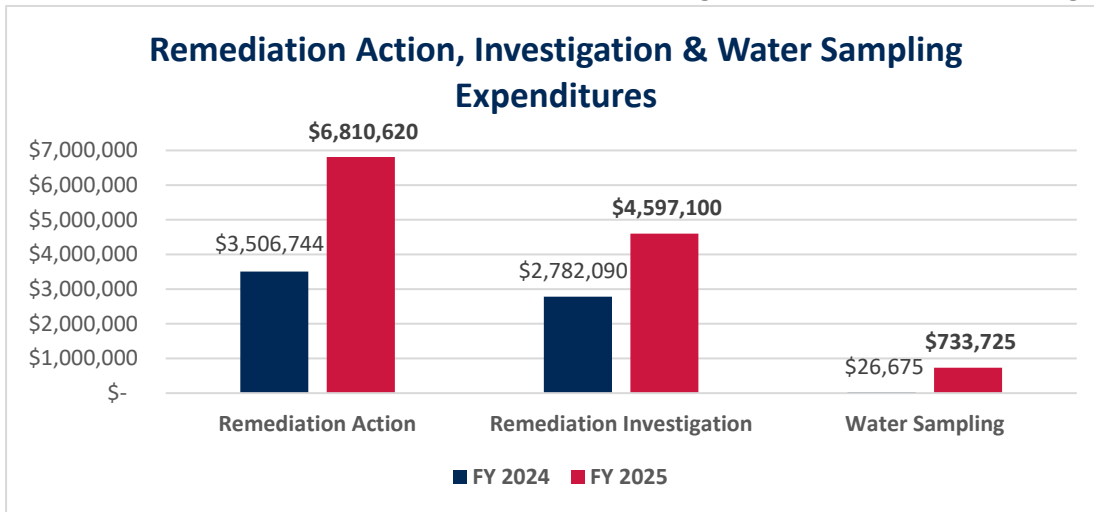

Environmental cleanup expenses totaled \$12.5 million in FY 2025, primarily driven by remediation (54%), investigation (37%), and water sampling (6%) activities. See Exhibit 5 for a breakdown of expenditures and a comparison with SFY 2024 .

Findings and Recommendations

North Carolina Faces a Multi-Decade Challenge in Addressing Inactive Hazardous Substance and Waste Disposal Sites

North Carolina has identified 688 former landfill sites that predate modern environmental regulations and may pose environmental and public-health risks. As of June 30, 2025, 534 of those sites (78%) have never been investigated. For most of these sites, the State does not know what contamination may be present, how far it may have spread, or whether it presents a current risk to nearby residents.

State law requires DEQ's Pre-Regulatory Landfill Program (Program) to monitor these sites.

Auditors examined the Program's site inventory, status tracker, risk assessments, and both public and internal records detailing site locations and environmental sampling. This review found that, while the Program identified and catalogued these sites, the majority have not yet undergone systematic review or testing.

The Scale of the Problem

Approximately 84% of the 688 sites in the Program's inventory are located within 1,000 feet of one or more residences, schools, daycares, churches, or potable wells, posing significant unknown risks to public health and the environment.¹⁴

Without monitoring across these 688 sites, the State lacks reliable information to determine whether hazardous substances are present, whether they pose a risk to public health, or whether additional investigation or remediation is needed. As a result, pre-regulatory landfill sites, including public parks located on former incinerator or dump sites, may remain unassessed for years, increasing the risk of public exposure to hazardous vapors, explosive gases, and other uncontrolled contaminants.

What Has Been Found on Sites Investigated

Where investigations have occurred, they have identified significant hazards.

As of June 30, 2025, 23 of 97 sites (23.7%) that completed the investigation phase or advanced beyond it had methane concentrations exceeding the lower explosive limit of 5% within the waste disposal area, indicating conditions that could support ignition.¹⁵ This suggests similar risks may exist at unmonitored sites but remain undetected due to the lack of monitoring.

Contaminants¹⁶ identified at or around investigated Program sites include:

- **Trichloroethylene (TCE):** TCE is an industrial solvent found in cleaning and degreasing products. Exposure can cause cancer and damage the liver, kidneys, immune system, and central nervous system.
- **1,4-Dioxane:** 1,4-Dioxane is a solvent used in chemical manufacturing that can contaminate groundwater and is likely carcinogenic to humans.
- **Lead:** Lead is a toxic metal often found in old paint, pipes, and contaminated soil. Exposure can cause developmental delays in children and damage to the nervous system and kidneys.
- **Methane:** Methane is a flammable gas produced by decomposing organic material in landfills. High concentrations can pose explosion risks and contribute to poor air quality.

Without routine monitoring of sites that predate modern environmental regulations, the presence and severity of contamination at many locations remains unknown.

The need for timely monitoring and remediation is underscored by several sites where threats to public health have already been identified, including Cliffdale Landfill in Fayetteville, several parks in Durham, and Southside Park in Charlotte. Exhibit 7 summarizes Program investigations at these sites, and Appendix F provides additional site information and maps.

¹⁵ To determine the presence of methane at a landfill, probes need to be installed and sampled. There is no mechanism available to establish the presence of methane by using the attribute data collected for risk scoring. As a result, direct access to the landfills is required to measure methane concentration.

Why Sites Remain Unmonitored: Funding Limitations and Inaccessible Properties

The Program's inability to monitor all sites and advance them to remediation in a timely manner primarily stems from **two** key constraints:

1. The Program does not receive sufficient annual funding to meaningfully reduce the site inventory.
2. The Program cannot investigate privately owned properties without owner consent.

Together, these constraints significantly limit the Program's ability to monitor sites and advance them through investigation and remediation.

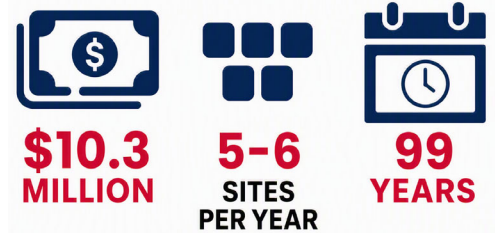
Funding Limitations

The Program's establishing legislation imposes a statewide solid waste disposal tax of \$2 per ton for waste disposed of at permitted landfills.¹⁸ Fifty percent of the disposal tax is deposited into the Inactive Hazardous Sites Cleanup Fund (Fund).¹⁹ The Fund has received an average of \$12.1 million annually between July 2019 and June 2025.

Program management estimates the average cost to investigate, assess, and remediate a site is approximately \$1.9 million.

After accounting for estimated administrative expenses of about 15.5% in fiscal year 2025, approximately \$10.3 million is available each year for site work.

At that funding level, the Program can complete remediation at only five to six sites annually. As a result, even under a conservative scenario, remediating all remaining sites and bringing them to a No Further Action (NFA) status would take approximately 99 years.²⁰



Recommendation:

DEQ should:

- Periodically reassess whether the current sequencing of "Activity Pending" sites reflects both **statutory** risk-based requirements and the most efficient use of limited funding.
- Evaluate options for obtaining additional financial or programmatic support.

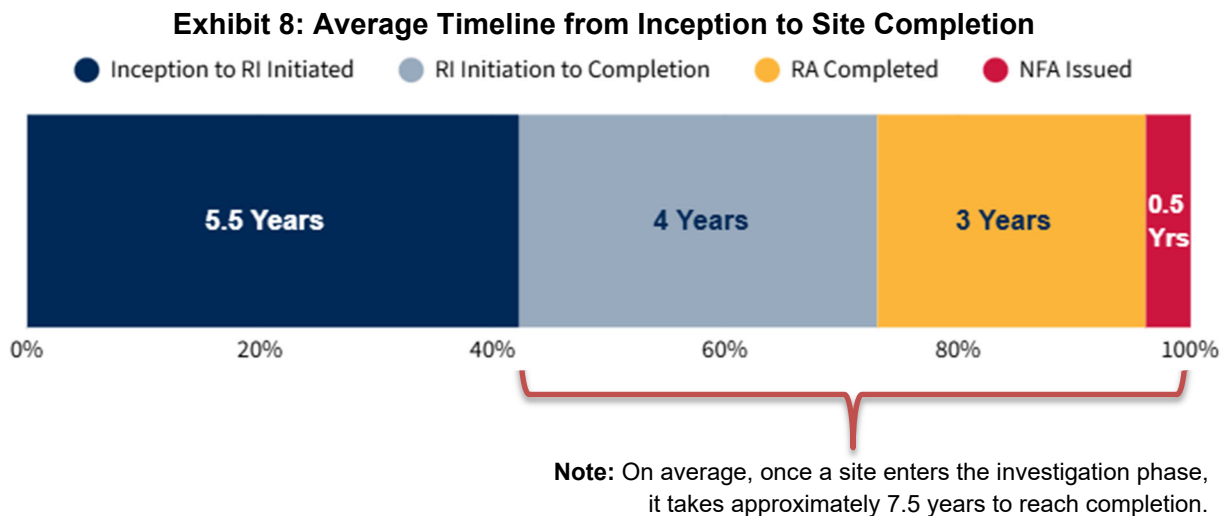

²⁰ This is an estimate based on remediating 5-6 sites per year of the 534 sites remaining in Phase 1. This estimate does not account for contractor increases, potential sites that do not need remediation, or future program funding fluctuations.

Resource constraints are compounded by the inherently sequential and labor-intensive nature of the work. Each site requires individually negotiated property access, environmental sampling, laboratory analysis, risk assessment, remedy design, and, where needed, construction of containment or cleanup measures. These steps require time and cannot be completed more quickly without additional funding.

The Program currently manages active work on 50–55 sites at a time, with an additional 30–40 prioritized for emerging issues. As of June 2025, only 124 sites were assigned to both a project manager and an external contractor.

Historical data demonstrates the Program’s lengthy timelines. For the 37 sites that have reached NFA status, the average time from the Program’s inception to NFA designation was about 13 years, as shown in Exhibit 8 below.

For example, the Red Oak Landfill (ranked #6 on the *Risk Priority Listing*) illustrates the complexity that can extend timelines. Investigators discovered additional disposal areas, requiring further assessment, a redesigned remediation plan, public comment, and re-solicitation of contractors. What appeared to be a straightforward high-priority site ultimately required years of additional work. (See Appendix I for the full Red Oak Landfill timeline.)

To further illustrate these resource limitations, contractor hourly rates have increased substantially over the past decade: 29–63% for Investigation/Remediation Design and 54–96% for Remediation Oversight. (See Appendix H for more information on contractor hourly rates over time.)

These increased rates mean that the cost of 100 hours of work a decade ago would fund only about 70 hours of Investigation/Remediation Design or 60 hours of Remediation Oversight today.

Investigation/Remediation Design- up to 63% cost increase

Remediation Oversight - up to 96% cost increase

Access to Privately Owned Sites

The Program generally cannot investigate a site without property-owner permission.²¹ Based on Program management review of parcel ownership data, approximately 78% of sites identified by the program are privately owned. This creates a significant barrier that compounds the funding constraint. Even well-funded programs cannot investigate sites where owners decline to grant access.

As of June 30, 2025, 18 sites in active investigation had at least one property owner who had not granted access. Nine sites in remediation planning were similarly stalled because property owners did not agree to sign Land Use Restrictions (LUR) or Notices of Environmental Contamination (NoEC). In some cases, these delays persisted for years. (See Appendix C for a listing of sites with pending access issues.)

For example, the East Wake County Landfill (ranked number 1 on the *Risk Priority Listing*), cannot be investigated further until the property owners clear debris from the site. However, the property owners rely on rental income from tenants on the property and cannot afford to evict them.

Recommendation:

DEQ should clarify and strengthen its legal authority to access privately owned sites where investigation is warranted and develop clear internal policies for exercising that authority.

Under the North Carolina General Statutes, if the Secretary of DEQ determines that an imminent hazard exists, they may order any known responsible party to take immediate action to eliminate or correct the condition.²² The Secretary, in their discretion, may also take such action without issuing an order.²³ DEQ is also authorized to seek administrative search and inspection warrants to access private property in the absence of the property owner consent.²⁴ However, the Program has not yet used its imminent hazard authority or secured warrants to access private property containing pre-1983 landfills.

Recommendations

To strengthen oversight of inactive hazardous substance and waste disposal sites, the Office of the State Auditor makes the following recommendations:

Recommendation 1 – Address Resource Constraints

DEQ should take steps to maximize the impact of existing Program resources and pursue additional resources to reduce the number of sites that remain unmonitored.

Specifically, DEQ should:

- Periodically reassess whether the current sequencing of “Activity Pending” sites reflects both statutory risk-based requirements and the most efficient use of limited funding. Sites with cooperative property owners may warrant prioritization where risk levels are comparable.
- Evaluate options for obtaining additional financial or programmatic support, including legislative appropriations, federal grants, interagency partnerships, and other funding mechanisms, to address long-standing resource constraints that limit the Program’s ability to advance sites in a timely manner.

Although statutory requirements rightly emphasize prioritizing risks, regularly reassessing both the risks themselves and their relative importance could enable the Program to use available resources more efficiently to address environmental exposures.

Recommendation 2 – Strengthen Mechanisms to Access High-Risk Sites

Specifically, DEQ should:

- Work with the General Assembly to improve access to high risk sites, including:
 - Clarifying the circumstances under which § 130A-310.5’s imminent hazard authority may be invoked to compel access to privately owned pre-regulatory landfill sites, and
 - Creating a distinct, lower threshold access pathway for high-priority pre-regulatory sites.
- Develop clear internal policies on when and how enforcement or emergency authorities should be exercised for high-risk sites.
- Develop a systematic plan to address sites where access has been denied, including escalation protocols for high-priority sites, and prioritize sites with cooperative property owners where risk levels are comparable.

Without timely access, even the highest priority sites may remain uninvestigated for years, extending already lengthy timelines, increasing risks to nearby residents and limiting the effectiveness of the State’s investment in cleanup activities.



Objective, Scope, and Methodology

Objective

The objective of this performance audit was to determine whether the North Carolina Department of Environmental Quality (DEQ), Division of Waste Management (DWM), monitored inactive hazardous substance or waste disposal sites under the Pre-Regulatory Landfill Program (Program) in accordance with State law, DWM policies and procedures, and best practices.

Scope

The audit scope included the Program from July 1, 2019 through June 30, 2025, with background and site monitoring analysis dating back to the Program's inception in 2007.

Methodology

To determine whether the objective was met, auditors performed the following procedures:

- Interviewed DEQ, DWM, and Program staff.
- Reviewed site data, supporting documentation, and other relevant records.
- Reviewed monitoring efforts performed by Program staff.
- Reviewed and analyzed Program financial data, contractor invoices, and funding history.

Auditors conducted a comprehensive review of Program documentation for all identified sites to determine each site's monitoring status and the length of time spent in each monitoring phase. This work included evaluating whether the Program followed its monitoring policies and procedures.

Specifically, auditors:

- Analyzed the full population of Program sites to determine the length of time each site spent in each monitoring phase.
- Visited two Program sites and interviewed contractor staff regarding site investigation and remediation activities.

Because of the test nature and other inherent limitations of an audit, together with limitations of any system of internal and management controls, this audit would not necessarily disclose all performance weaknesses or instances of noncompliance.

This audit was designed to identify, for those programs, activities, or functions within the audit scope, deficiencies in internal control significant to our audit objectives. As a basis for evaluating internal control, auditors applied the internal control guidance contained in professional auditing standards. However, this audit does not provide a basis for rendering an opinion on internal control, and no such opinion is provided.

We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objectives.

Recommendation 1 – Address Resource Constraints

DEQ should take steps to maximize the impact of existing Program resources and pursue additional resources to reduce the number of sites that remain unmonitored.

Specifically, DEQ should:

- Evaluate options for obtaining additional financial or programmatic support, including legislative appropriations, federal grants, interagency partnerships, and other funding mechanisms, to address long-standing resource constraints that limit the Program’s ability to advance sites in a timely manner. Although statutory requirements rightly emphasize prioritizing risks, regularly reassessing both the risks themselves and their relative importance could enable the Program to use available resources more efficiently to address environmental exposures.

Pre-Regulatory Landfill Program Response – Address Resource Constraints

The Pre-Regulatory Landfill (PRLF) Program agrees with the findings and recommendations to address resource constraints.

- The PRLF Program is a risk-based program that uses risk priority scoring to identify landfill sites that are higher priority. The scoring system is based on current conditions such as proximity to potable wells, occupied structures on top of the landfill, residences, schools, daycares, and churches within 1,000 feet of the landfill, and the landfill size. The risk priority score can change quickly at any given landfill site due to population growth and redevelopment of properties in North Carolina. The PRLF Program has diligently focused on high-risk sites based on risk score and redevelopment priority. Due to the size, wide array of potential contaminants of concern, and site-specific conditions it can take many years to delineate the extent of contamination and impacts from unlined and unregulated landfills. However, evaluating receptors around these landfills and updating priority scores provides a level of monitoring at these sites. The following bullets capture the efforts of the PRLF Program staff and contractors to address the statutory requirement of locating, cataloguing, and monitoring waste disposal sites.
- The PRLF potable well sampling project initiated in 2024 provides a snapshot of groundwater conditions surrounding landfill sites and provides the PRLF Program valuable information on the number of potable wells, current drinking water conditions for the wells sampled, and contact information for the well owners. By monitoring all the landfill sites on a 5-year cycle (depending on the site priority ranking), the PRLF Program captures groundwater conditions, evaluates contaminants of concern in potable wells, and updates risk scores for landfill sites. The information and data obtained through this project will help address the resources constraints by enabling the Program to use available resources more efficiently to address environmental exposures.

- The PRLF Program is developing a property owner participation policy to address cooperative property owners at landfill sites with comparable risk levels. Identifying cooperative property owners will help expedite and complete investigations and remedial action plans, reducing the total time it takes to complete a landfill site.
- In addition to the property owner participation policy, the PRLF Program will be sending letters to all landfill owners informing them they have an unregulated landfill on their property. The letters will also inform the landfill owners of the risks associated with unlined and unregulated landfills, the inherent responsibility of owning a superfund site, and to serve as a litmus test for property owner participation in the PRLF Program. The letters will help to maximize the impact of existing program resources by notifying property owners of the risks with these landfills and encouraging involvement in the program.
- The PRLF Program sent 755 letters to county health directors, county managers, and municipality leadership informing them of all landfill sites in their respective jurisdictions and an additional 58 letters were sent to park directors and city or county leadership informing them that a park or recreational area was located on top of a landfill site. These letters were distributed with the goal of informing local government leadership the presence of landfill sites in areas they control for planning and redevelopment activities, risks posed by PRLFs, and to inform DEQ if they have plans for a landfill site. The local government letters will be distributed on an annual basis to assist with risk management of landfill sites and will help to maximize program resources through direct communication with local officials to understand current and future uses of these areas.
- The PRLF Program has created new status levels for tracking sites and showing status to reflect greater detail on various conditions present at landfill sites. These new status levels will help with tracking progress at landfill sites and managing multiple property owners, creating greater visibility and efficiency improvements within the Program. Part of the new tracking procedure allows the PRLF Program to complete partial investigations and partial remedies for participating property owners while capturing properties that are not assessed or remediated.
- The PRLF Program has identified an opportunity to decrease the amount of time the delineated waste disposal area is closed or remains unsafe for use by implementing an interim remedial action plan to cover the waste disposal area with twelve inches of clean soil before the investigation is complete. Historically, the PRLF Program initiated the investigation and invested the resources and time needed to delineate the full extent of contamination and impacts from the landfill (migrating landfill vapors and groundwater contaminants beyond the waste disposal area boundary) before developing an interim remedial action plan to address portions of the landfill. Offering an interim remedial action plan to cover the waste disposal area after the waste boundary has been delineated, allows the PRLF Program to address a significant portion of the overall site more efficiently. Covering and stabilizing exposed and eroding waste is an important step towards achieving risk management at landfill sites.
- The PRLF Program is pursuing the option of using the Bernard Allen Program staff and existing contracts to assist with supplying bottled water and filtration systems when a potable well is deemed unsafe for continued use. The Bernard Allen Program has

efficiencies with subcontractor rates and scale that would offer meaningful financial savings for the PRLF program without sacrificing customer service and protection.

- Additional legislative funding would help offset the increase in costs to complete investigations and remedial action plans. The excise tax of two dollars (\$2.00) per ton of waste (N.C.G.S 105-187.61) was established in 2007 and has not been adjusted for inflation. The cost of implementing a remedial action plan has increased at an annual rate of 17.8% over the past eight years. From 2009 to 2026, PRLF contractor oversight fees have increased between 57% and 140% depending on the personnel level identified in our contracts. DEQ will evaluate the options for additional funding for the pre-regulatory landfill program. This work will include the drafting of any necessary legislative changes in regard to statutory language or fee changes.
- These associated changes will be evaluated and implemented over the next six months with Director Michael E. Scott being responsible for the actions.

Recommendation 2 – Strengthen Mechanisms to Access High-Risk Sites

Specifically, DEQ should:

- Work with the General Assembly to improve access to high-risk sites, including:
 - Clarifying the circumstances under which § 130A-310.5's imminent hazard authority may be invoked to compel access to privately owned pre-regulatory landfill sites, and
 - Creating a distinct, lower threshold access pathway for high-priority pre-regulatory sites.
- Develop clear internal policies on when and how enforcement or emergency authorities should be exercised for high-risk sites.
- Develop a systematic plan to address sites where access has been denied, including escalation protocols for high-priority sites, and prioritize sites with cooperative property owners where risk levels are comparable.

Pre-Regulatory Landfill Program Response – Strengthen Mechanisms to Access High-Risk Sites

The PRLF Program agrees with the findings and recommendations to access high-risk sites. The PRLF Program plans to implement the proposed changes outlined below and then evaluate the effectiveness of the proposed programmatic changes before working with the General Assembly to potentially clarify or change existing statutes.

- The PRLF Program will be sending letters to all PRLF owners informing them they have a pre-regulatory landfill on their property. The letters will explain the PRLF Program and benefits of participation and conversely, the responsibility of owning a superfund site if participation is not desired. The letter will request access to the properties and explain how that access will be used to conduct limited assessment activities to determine if there are any imminent risks associated with the landfill and to establish minimum information to prioritize the site. Sites where access is not granted outright or there is no response to our requests will be put

on a non-participation list and no further actions will be taken (unless there is an imminent risk determined) other than continuing to mail out the information letter on an annual basis to also consider changes in property ownership.

- DEQ is developing a systematic plan to prioritize sites with cooperative property owners where risk levels are comparable to ensure these sites are addressed. Sites where property access is obtained will be put on a separate list with willing participants and assessment activities will be conducted as funds are available.
- The PRLF Program is developing an internal policy to address management of landfill site properties where access has been denied or rescinded and escalation protocols for properties that have documented imminent hazards.
- Where access has been denied, properties where the public has use of the site (parks and recreational areas) and may be exposed to potential risks obtaining access will be escalated to contacting local and state public health authorities and other pertinent local or county officials to address public exposure. If access is still not obtained, other measures will be considered, including administrative warrants to collect minimal data to determine if potential risks are present. Where access has been denied on private property where the public does not access the site, the site will remain on the non-participation list.
- As with other programs such as the Dry-Cleaning Solvent Cleanup Act (DSCA) program, the presence of potential dry-cleaning solvent contamination sites are listed and shown on the DWM Locator tool map for information purposes only. These sites are not 'in' the DSCA program until there is a willing participant. The PRLF program will be evaluated to see if structuring in this same method as the DSCA program could be advantageous.
- DEQ does not believe that the imminent hazard standard in § 130A-310.5 needs to be clarified. The statute gives a clear and specific standard for what constitutes an imminent hazard and what authority DEQ has in such a case. DEQ has never used that authority because DEQ is judicious in accessing any site where an owner denies access. But the authority remains critical in the unlikely event that a hazard, such as a high likelihood of an explosion, is imminent, and the owner is absent or refuses to act. In such a case, it is important that DEQ has the legal tools to access the site and take immediate emergency action. While DEQ understands the desire for a clear policy on when the authority should be exercised, such a determination is necessarily a fact-specific, case-by-case inquiry that depends on factors unique to each site. DEQ will further evaluate the circumstances under which 130A-310.5 imminent hazard authority may be applicable to the pre-regulatory landfill program and high-risk sites as participation levels are determined and assessments are completed.
- What is currently deemed a high-risk priority is based on attribute information for each landfill site and this provides the best screening process without obtaining actual samples from the landfill site. There is an underlying assumption that if receptors such as potable wells and occupied structures are on top of the landfill site or within 1,000 feet there could be a situation where the occupants and users of the potable water are being exposed to contamination from the landfill. The PRLF Program cannot quantify risk and determine the severity of conditions at each landfill site without assessment information such as landfill vapor, surface water, groundwater, and soil samples (all which are obtained with property access approvals).



- DEQ will evaluate additional approaches to providing a lower threshold access pathway for high-priority pre-regulatory sites. The PRLF Program will establish a lower threshold to access high risk sites by implementing the processes outlined in the bullets listed for response number two above. This new process will focus on sites with high-risk scores and public use, such as parks and recreational areas.
- These associated changes will be evaluated and implemented across the next six months with Director Michael E. Scott being responsible for the actions.

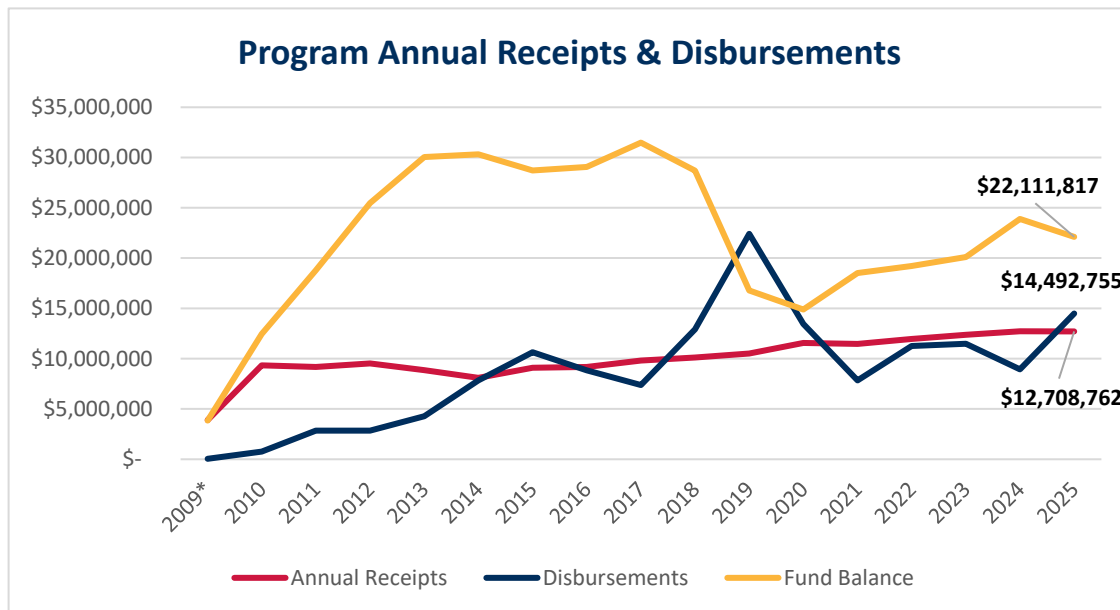

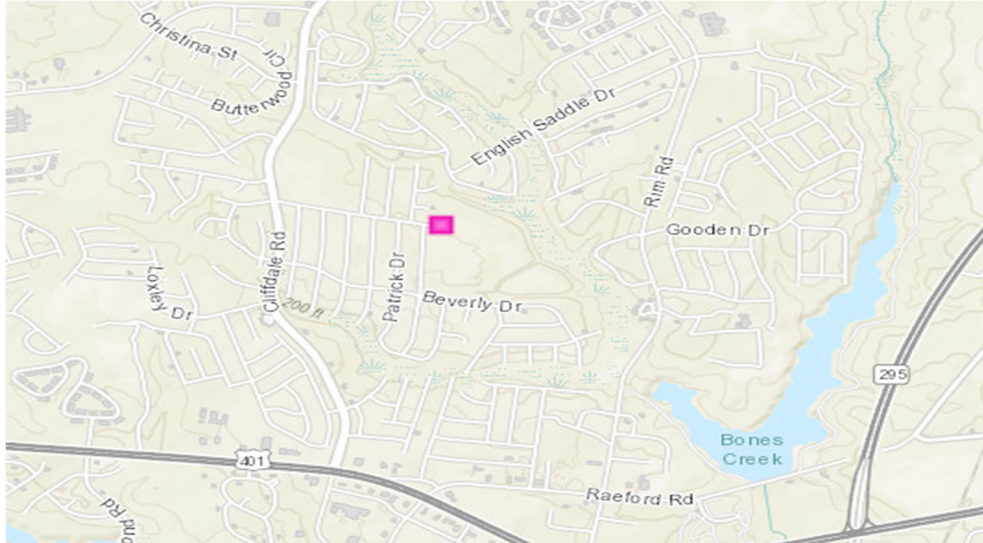

Cliffdale Landfill

The Cliffdale landfill site's formal name is the Cumberland County/Cliffdale Landfill located at 7583 Lowell Harris Road in Fayetteville, NC.

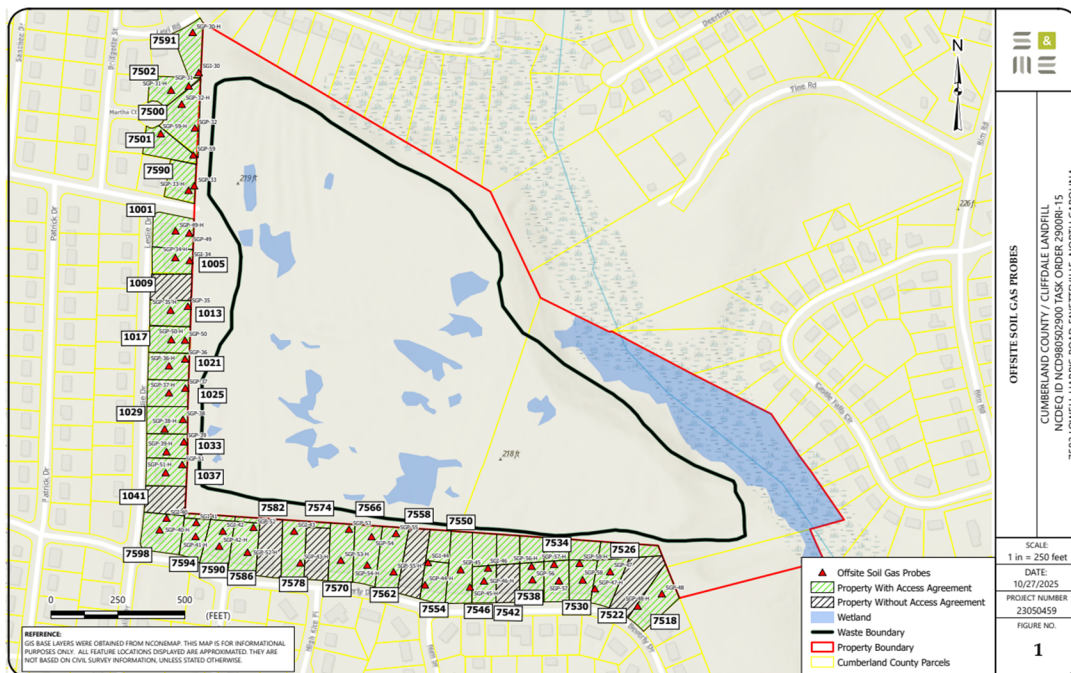
Cliffdale Landfill Location Map

Investigators assessed the site by installing and sampling soil-gas probes within the waste disposal area and on adjacent boundary-line properties where access was available. Testing detected methane concentrations indicating a risk of ignition, as well as low levels of hydrogen sulfide, which can cause headaches, nausea, fatigue, and throat and eye irritation. Of the 37 properties that share a boundary with the site, soil-gas probes were installed on 26, and initial testing in September 2024 showed methane levels exceeding the lower explosive limit at 24 of the 26 sample locations and detectable hydrogen sulfide at 25 of the 26 locations.

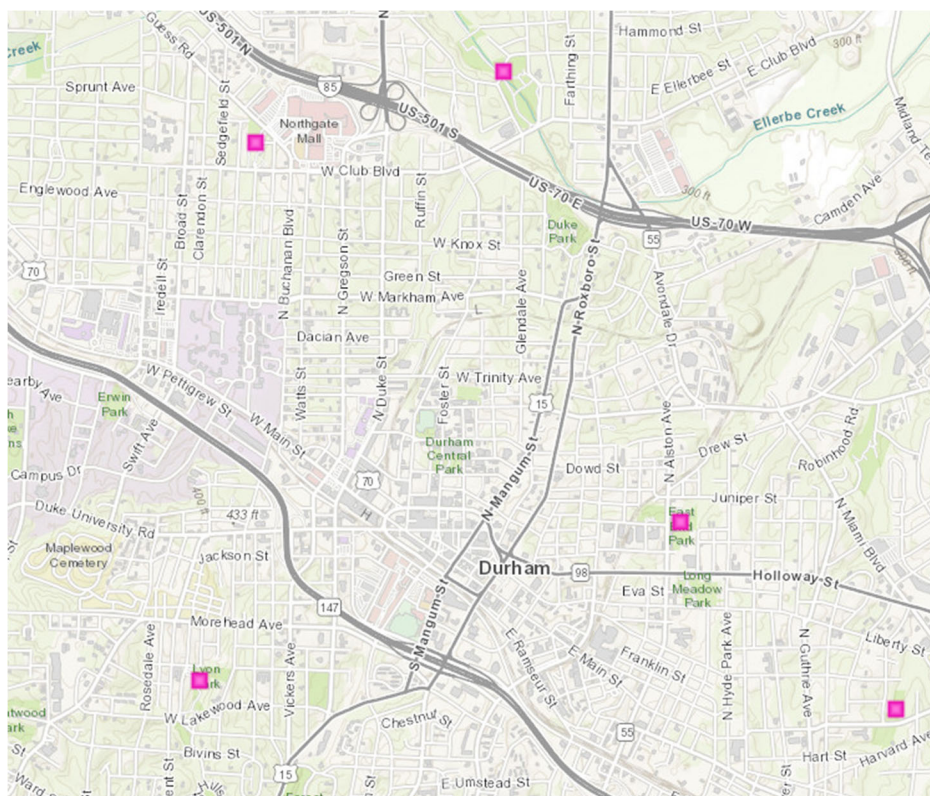

Durham Parks Location Map



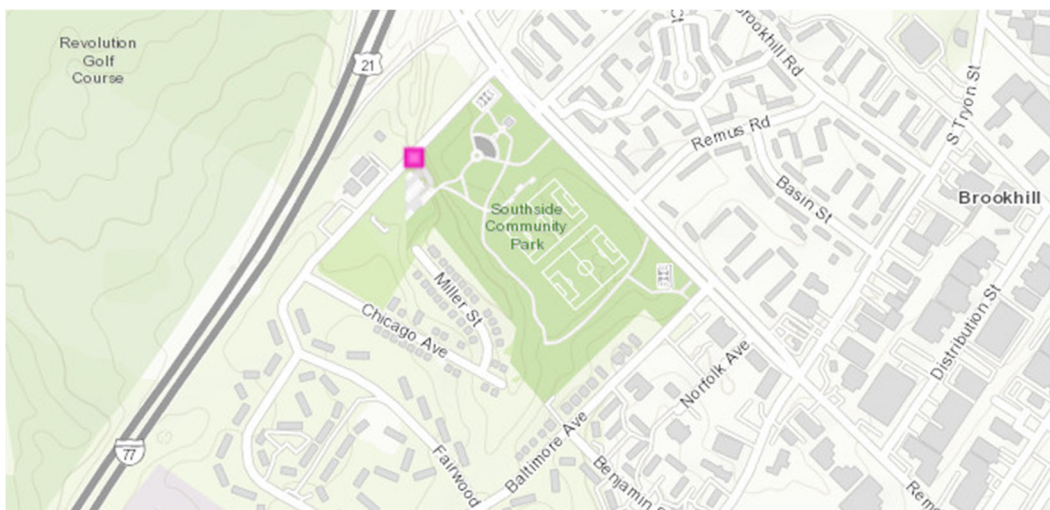

Based on the remedial investigation reports of each Park between 2021 to 2024, the results noted composite grid location samples exceeding the U.S. Environmental Protection Agency “USEPA” health-based screening greater than 200 mg/kg, ranging from 7% to 57% of samples tested.

Southside Park

Southside Park is located at 2645 Toomey Avenue in Charlotte, North Carolina (the City). This is a 21-acre park that includes a playground, shelters, basketball courts, and athletic fields. However, the land has a long history of waste disposal. According to City Parks and Recreation records from 1966, much of the area was previously used as a landfill and incinerator site from the 1940s through the mid-1950s, before portions were later converted into public recreational uses.

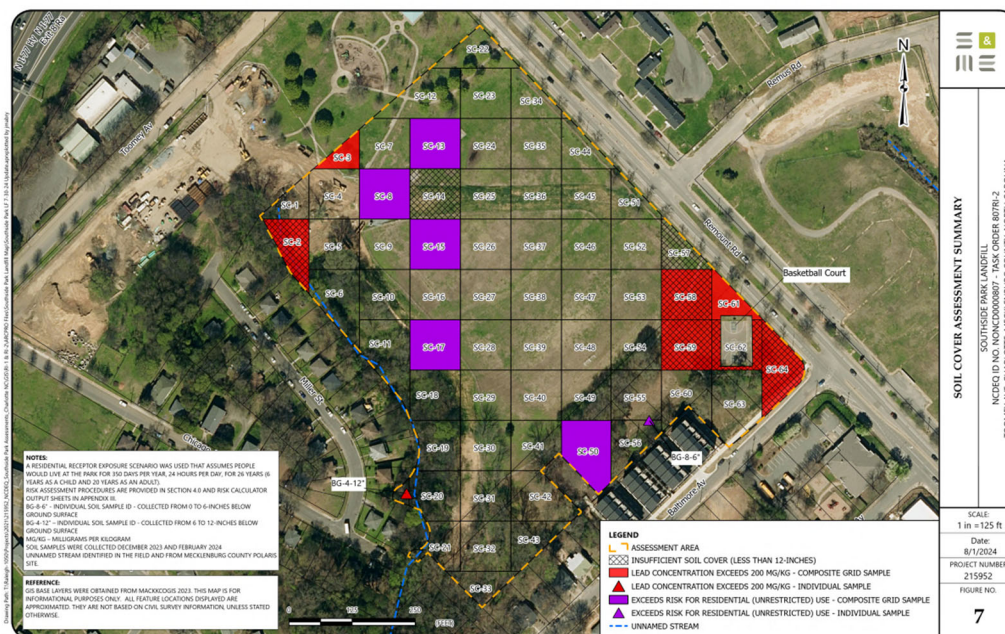
Southside Park Location Map

An initial environmental assessment was completed in 2010. Over 10 years later, the Program began further assessment of the former landfill. In February 2025, the park was closed after testing identified elevated levels of lead and cobalt in the soil. Lead concentrations exceeded acceptable thresholds in 14 of 64 samples collected, as shown below.

Appendix G: Site Progression Timeline – Southside Park

This appendix provides a year-by-year timeline of investigation and response activities at Southside Park in Charlotte, North Carolina (the City), illustrating how long site-specific work can take from initial entry to active assessment.

Initial Documentation

- 1966 – A City Parks and Recreation document identified historical landfill activity at the site.
- July 21, 2010 – Schnabel Engineering prepared a Site Summary Report documenting known site conditions.

Redevelopment Trigger & Program Engagement (2021)

- February 8, 2021 – Mecklenburg County (the County) contacted the Pre-Regulatory Landfill Program (the Program) regarding planned redevelopment of the site.
- February 9, 2021 – The Program provided the Site Summary Report to the County and advised that no physical investigation had been conducted and that the waste footprint and potential environmental impacts were unknown.
- June 18, 2021 – The County requested that the Program initiate a landfill assessment.
- June 24, 2021 – The Program requested access agreements from the County and the City due to shared property ownership.
- July 16, 2021 – The County and the Program held a scope and timeline coordination meeting.

Access Delays & Coordination (2021–2023)

- September 2021–October 2023 – Assessment activities were delayed due to the lack of access approval from the City. During this period, the County submitted repeated follow-up requests; however, the City did not render a decision.
- October 2023 – The County requested that the Program proceed with assessment activities limited to County-owned property.

Remedial Investigation – Mecklenburg County Property (2023–2024)

- October 12, 2023 – The Program held a project kickoff meeting with S&ME (the Contractor).
- October 16, 2023 – The County granted site access.
- January 2024 – Soil cover sampling identified exceedances of lead and cobalt.
- September 2024 – The Program transmitted project information and the soil cover sampling report to the County, including notification of lead and cobalt exceedances.

Expansion to City of Charlotte Property (Late 2024)

- October 23, 2024 – The City executed an access agreement, approximately three years after the initial request.
- Following access approval, geophysical surveys and waste delineation activities began on the City-owned portion of the site.

Risk Management & Community Engagement

- November 6, 2024 – Fencing was installed to restrict public access to areas with impacted soil.
- November 12, 2024 – The Program, the Contractor, and the County’s Public Health Department held a community meeting to discuss site conditions and next steps.

Advanced Investigation (2025)

- January 2025 – Waste delineation and media sampling were conducted, and remediation cost estimates were developed.
- January 30, 2025 – The Department of Environmental Quality (DEQ) published a project-specific website.
- March 27, 2025 – The Program submitted a report summarizing the acquisition of off-site access agreements for five properties to support additional delineation activities.
- May 5, 2025 – The Contractor submitted a remediation cost estimate limited to soil cover (excluding removal of impacted soil).
- Late 2025 – The Contractor completed a topographic and boundary survey and issued reports documenting additional waste delineation and first-round media sampling (soil gas, groundwater, and surface water/sediment).
- During this period, access requests were submitted to multiple residential properties to evaluate potential waste extension and to conduct additional delineation and sampling, as necessary.
- The Program, the Contractor, the County, and the City conducted project update and coordination meetings, including preparation for a community meeting.

Current Status & Next Steps (2026)

- The site remained in the Remedial Investigation phase.
- Access efforts continued for 14 residential properties located on Miller Street and Chicago Avenue.
- January 2026 – A second round of soil gas, groundwater, and surface water sampling was conducted.
- February 17, 2026 – A community meeting was scheduled.
- Future activities included preparation of the Remedial Investigation Summary Report and a draft Remedial Action Plan.

Appendix I: Site Progression Timeline – Red Oak

This appendix provides a year-by-year timeline of investigation and remediation activities at the Red Oak Landfill in Nash County, illustrating the complexity and time that a site can require.

Red Oak Landfill – Timeline Summary

Early Investigation and Site History (2015–2018)

- 2015–2016 – The contractor conducted water supply well sampling that identified 1,4-dioxane in one well and submitted supporting Hydrogeologic Evaluations.
- October 2015 – The contractor completed and submitted the Final Remedial Investigation Summary to the Pre-Regulatory Landfill Program (the Program).
- November 2016 – The contractor completed a post-storm inspection following Hurricane Matthew.
- 2017–2018 – The Program and the contractors reported no documented site activity during this period.

Program Funding Impacts and Project Reinitiation (2019–2020)

- March 2019 – Legislative changes significantly reduced Program funding, resulting in staffing impacts and delayed project activity.
- July 2020 – A Program project manager was hired and subsequently assigned to the site.
- October 2020 – Sampling activities for landfill gas, groundwater, and potable water were reinitiated by the contractor.

Focused Investigation and Assessment (2021–2023)

- 2021 – The contractor performed groundwater, potable water, and soil gas investigations for volatile organic compounds (VOCs) and 1,4-dioxane.
- June 2022 – The contractor received its first remedial action task request and initiated remedy-related studies.
- April 2023 – The contractor submitted the Draft Remedial Action Plan.
- June–July 2023 – Additional remedial design and cost estimate proposals were submitted by the contractor.

Public Involvement and Remedy Redesign (2023–2024)

- May–October 2023 – The Program conducted a public comment period and held a public hearing regarding the proposed remedy plan.
- February 2024 – The contractor was tasked with redesigning the remedy in response to public input.
- October 2024 – The final redesigned Remedial Action Plan was completed.

Procurement and Remedy Implementation (2024–2025)

- Late 2024–Early 2025 – Multiple bid solicitations were issued due to limited contractor response.

- March 2025 – A subcontractor was selected following re-advertisement and evaluation.
- May 2025 – Remedial construction activities commenced.
