NPDES (National Pollutant Discharge Elimination System) Stormwater Construction General Stormwater Permit

What Activities Require This Permit? Construction activities that disturb more than an acre of land are required to get an approved Erosion and Sedimentation Control Plan (E&SC) and coverage under the Construction General Stormwater Permit (NCG01).

What Is The Purpose of This Permit? To manage and store pollutants on construction sites in a manner that prevents pollution of surface waters. Sites covered under this general permit are required to develop a Stormwater Pollution Prevention Plan (SWPPP).

The SWPPP includes:

- Approved E&SC plan.
- Sample plan sheet for Ground Stabilization and Materials Handling (add to E&SC plan)
- Sample plan sheet for Self-Inspection, Record-keeping and Reporting (add to E&SC plan)

Who Issues This Permit? N.C. Division of Energy, Mineral and Land Resources (DEMLR), Stormwater Permitting Program

How Much Will This Permit Cost?

New/Annual fee for Certificates of Coverage under General Stormwater Permits: \$100 - (NCG01 annual permit fees of \$100 are scheduled to go into effect on August 1, 2019)

What Are My Payment Options for Permit Application Fees?

Most application fees can be paid by check or money order. Annual fees can be paid online at <https://deq.nc.gov/about/divisions/energy-mineral-land-resources/energy-mineral-land-permits/stormwater-program/stormwater-epayments>.

If Paying by Check, Who do I Make the Check Payable to? Checks, money orders should be made payable to: Division of Energy, Mineral and Land Resources (or DEMLR) – Stormwater

How Long Will It Take To Review My Application? After receiving approval of E&SC plan, the electronic Notice of Intent (eNOI) is submitted to receive a Certificate of Coverage (COC) under the NCG01 permit. Within three business days, DEMLR will issue the COC via email to the applicant (if the form is complete and correct). After completion of a project, the final step is to submit an electronic Notice of Termination (eNOT) from to end coverage under the NCG01 Permit.
