Explanation: The Division of Water Resources requests approval to proceed to the Environmental Management Commission for public hearing for proposed amendments to 15A NCAC 02L .0100 “Groundwater Classifications and Standards – General Considerations.” The purpose of the rule-making is to incorporate changes required by Session Law 2018-114 Sections 19.(a)–(e) and 19.1(a)–(e) and Session Law 2020-74 Section 17.1(a)–(e).

Recommendation: The Division recommends that the GWWMC approve the proposed amendments of 15A NCAC 02L .0100 “Groundwater Classifications and Standards – General Considerations”, to go to the full EMC for approval to proceed to public hearing.
