

BLOCK OF 10 TEN-DAY COASTAL RECREATIONAL FISHING LICENSES APPLICATION INSTRUCTIONS

This application is to be completed and signed by individuals applying for a Block of 10 Ten-Day Coastal Recreational Fishing Licenses. Businesses requesting a block of licenses must have the Responsible Party (business agent) complete and sign the application. The Responsible Party is the person who coordinates, supervises or otherwise directs operations of a business entity, such as a corporate officer or executive-level supervisor of business operations and/or is the person responsible for use of the issued License in compliance with applicable laws and regulations. Individuals applying for a license for another under the authority of Power of Attorney must submit a **PHOTOCOPY** of the Power of Attorney and current picture identification.

Eligibility Requirements

The Coastal Recreational Fishing License is required for any angler engaged in recreational harvest of finfish in the coastal fishing waters of the state. The Block of 10 Ten-Day Coastal Recreational Fishing Licenses can only be sold for use on vessels that have a length of 23 feet or greater. The Block of 10 Ten-Day Coastal Recreational Fishing Licenses can only be sold for use on vessels that do not hold a For Hire Permit or Blanket For Hire Coastal Recreational Fishing License.

- A. Provide a **PHOTOCOPY** of <u>one</u> of the following current picture identifications:
 - Driver's License; or

- 4. Passport; or
- 2. State Identification (issued by DMV); or
- 5. Resident Alien Card (green card)

- 3. Military Identification; or
- B. A Block of 10 Ten-Day Coastal Recreational Fishing Licenses Application must have the following:
 - 1. Check one:
 - a. New Application (i.e., new License)
 - b. Replacing a Current License
 - 2. The license numbers if replacing the Block of 10 Ten-Day Coastal Recreational Fishing Licenses. These numbers are printed on each license to the right of the words *NC DMF Coastal Recreational Fishing Ten-Day License*.
 - 3. Complete all the applicable Participant Information, including Participant Identification number. This number is listed to the right of the word Participant # on any DMF license. If you do not currently have a license with DMF, leave this box blank.
 - 4. Vessel survey must be completed.
 - 5. Sign and date the Application.
 - 6. Completed Certification Statement Form. It must be notarized if applying for a new license.
- C. Enclose a **PHOTOCOPY** of valid NC Wildlife Resources Commission vessel registration or U.S. Coast Guard Vessel Documentation.
- D. <u>Fees</u>
 - 1. \$150.00
 - 2. Replacement Fee \$12.50
- E. Method of payment: Personal check, money order or Cashier check. Make payable to *North Carolina Division of Marine Fisheries*. There will be a \$25.00 service charge for returned checks.

You are required to notify the Division of Marine Fisheries of any address or residency changes within 30 days. Incomplete applications submitted without required documentation will be deemed incomplete and returned to you unprocessed.
