PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Stephen W. Murphey, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Friday, May 29, 2020.

All those waters in Carteret County will return to the status in existence immediately prior to the May 18, and May 22, 2020, temporary closures **except the following which will remain closed:**

CARTERET COUNTY

All those waters from the Intracoastal Waterway to the mainland between the Emerald Isle High-rise Bridge and IWW Channel Marker "65A", located just west of Salliers Bay near New River Inlet, to include Salliers Bay, Freeman Creek, Bear Creek, Queens Creek, White Oak River, and all other creeks and tributaries within said boundaries.

Bogue Sound - All those waters from the Intracoastal Waterway to the mainland between IWW Beacon "24" and IWW Marker "29".

Newport River - All those waters in Newport River upstream of a line beginning at a point 34° 44.8271' N - 76° 42.1709' W on the south shore near Crab Point; running northeasterly to a point 34° 46.3210' N - 76° 41.2515' W on the west shore of Core Creek.

North River - All those waters in North River upstream of a line beginning at a point on the west shore at 34° 46.0460' N - 76° 37.0517' W, running easterly to a point on the east shore at 34° 46.2731' N - 76° 35.4724' W (near the DMF Shrimp Line).

Oyster Creek - All those waters in Oyster Creek upstream of a straight line across the mouth, beginning at a point 34° 48.8185' N - 76° 26.9761' W on the west shore; running northeasterly to a point 34° 48.9768' N - 76° 26.6340' W on the east shore.

The following also remains closed:

BRUNSWICK / NEW HANOVER / PENDER / ONSLOW COUNTIES

All those waters bordered on the east by a line beginning at a point 33° 54.2904' N - 78° 23.6416' W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932' N - 78° 23.6426' W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the South Carolina State Line, to include the Tubbs Inlet area.

Shalotte River – All those waters in Shalotte River upstream of a line beginning at a point 33° 54.8302' N - 78° 22.3626' W near Bowen Point; running southeasterly to a point 33° 54.6139' N - 78° 21.7667' W on Long Point.

Holden Beach - All those waters bordered on the east by the permanent closure line near IWW Beacon "69"; and bordered on the west by a line beginning at a point 33° 54.6855' N - 78° 21.3550' W on the mainland; running southerly through IWW Marker "71" to a point 33° 54.4311' N - 78° 21.2898' W on Holden Beach near the end of Sea View Drive.

Lockwoods Folly River - All those waters north of a line beginning at a point 33° 55.5678' N - 78° 13.8043' W on the south shore of Spring Creek near the mouth; running easterly to a point 33° 55.4621' N - 78° 13.1714' W near the northern tip of Sheep Island; thence running southeasterly to a point 33° 55.2284' N - 78° 12.7791' W near the northwest point of Horse Island, to include a portion of the Intracoastal Waterway north of Horse and Sheep Islands.


All those waters in Myrtle Grove Sound, Masonboro Sound, and Middle Sound between the Figure 8 Island Bridge and Snows Cut.

All those waters in Stump Sound bordered on the north by a line beginning at a point 34° 28.2180' N - 77° 30.5521' W on the mainland near Morris Landing, running southeasterly near Beacon "49" to a point on Topsail Island at 34° 27.273' N - 77° 29.937' W; and bordered on the south by the Surf City Bridge.

All those waters from the Intracoastal Waterway to the mainland between the Emerald Isle High-rise Bridge and IWW Channel Marker "65A", located just west of Salliers Bay near New River Inlet, to include Salliers Bay, Freeman Creek, Bear Creek, Queens Creek, White Oak River, and all other creeks and tributaries within said boundaries.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. It should be noted that leases or franchises closed on or after April 8, 2020, to allow relaying of shellfish from closed areas remain closed.
- E. This proclamation returns the following areas to normal closure boundaries: a portion of Newport River, a portion of North River, Wards Creek, Whitehurst Creek, Sleepy Creek, Jarrett Bay, Brett Bay, and Nelson Bay.
- F. These reopenings are due to satisfactory bacteriological sampling results.
