PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Kathy B. Rawls, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following changes in shellfish harvesting areas will take effect at sunrise, Friday, August 20, 2021.

All those waters in Onslow and Carteret Counties will return to the status in existence immediately prior to the August 1, August 2, August 3, and August 4, 2021, temporary closures **except the following which remain closed:**

ONSLow / CARTERET COUNTIES

All those waters from the Intracoastal Waterway to the mainland between IWW Beacon "49" (34° 40.2621'N - 77° 07.9802' W), near Swansboro, and IWW Beacon "55" (34° 38.5749'N - 77° 10.8033' W), to include the Intracoastal Waterway and Queens Creek.

All those waters near the Swansboro waterfront bordered on the southeast by a line starting at a point 34° 40.9479' N - 77° 07.1405' W, near IWW Beacon "47", running southwesterly to a point 34° 40.3029' N - 77° 08.0079' W, near IWW Beacon "49".

All those waters from the Intracoastal Waterway to the mainland in Bogue Sound between IWW Beacon "24" and IWW Marker "29", to include the Intracoastal Waterway.

The following also remains closed:

BRUNSWICK / NEW HANOVER COUNTIES


All those waters between IWW Beacon "1" near Southport and the South Carolina State Line, to include Tubbs Inlet, Shallotte River, Shallotte Inlet area, Lockwoods Folly River, and Lockwoods Folly River Inlet area.

All those waters, from the Intracoastal Waterway to the mainland, between IWW Marker "149" (34° 06.5162'N - 77° 52.4234' W) near Peden Point and IWW Marker "155" (34° 04.8189'N - 77° 52.9654' W) near Carolina Beach Inlet, to include the Intracoastal Waterway.

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.
- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.

- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following areas to normal closure boundaries: White Oak River, the Bogue Inlet Area, and a portion of Bogue Sound including Goose Creek and Sanders Creek.
- E. These reopenings are due to satisfactory bacteriological sampling results.
