North Carolina Recreational Highly Migratory Species Reporting Requirements

The following **Highly Migratory Species (HMS)**, Atlantic bluefin tuna, blue marlin, white marlin, sailfish, and swordfish, landed recreationally in North Carolina must have a **Landing Tag** affixed before removal from the vessel. Captains or operators from trailered vessels must have the Landing Tag affixed before the vessel is removed from the water. Captains or operators of permitted vessels in North Carolina must use this method instead of the NMFS call-in or website reporting process. **HMS released alive should not be reported. Dead discards of Atlantic Bluefin Tuna should be reported. Highly Migratory Reporting Stations** have been established throughout coastal North Carolina. Please note that roundscale spearfish have been added to list of species that must be reported.
