Project Description: The proposed project is a “find and fix” sewer rehabilitation project to address inflow and infiltration, blockages, and exfiltration in the Town’s collection system. The following work is proposed:

- Smoke test inspections of 68,000 linear feet (lf) of gravity sewer within tributary areas of Northwood Pump Station (PS), Paul Payne PS, and Jay Dr PS. Repair of approximately 100 cleanouts, 30 manholes, five (5) illegal connections, and five (5) defective services.
- Rehabilitate and/or repair 10 manholes.
- Clean and CCTV inspections of 22,085 lf of gravity sewer. Prioritize rehabilitation and/or repair needs and begin work according to the funds available in the project budget. Estimated work is approximately 30 point repairs, replacement of 1,300 lf of 6-inch with 8-inch gravity sewer; and rehabilitate 14,375 lf of gravity sewer including 12,600 lf of 8-inch, 1,000 lf of 10-inch, 275 lf of 12-inch, and 500 lf of 15-inch gravity sewer with cured-in-place pipe (CIPP).

The above named applicant will receive funding assistance from the State Revolving Fund program to construct the wastewater facilities described above. The North Carolina Division of Water Infrastructure (Division) has conducted a review of the project in accordance with the procedures (NCAC 15A Subchapter 1C) for conformance with the North Carolina Environmental Policy Act. The Division has determined that this project is below the minor construction activities threshold outlined in 15A NCAC 01C .0408; therefore, the project is exempt from inter-agency review, and the preparation of additional environmental documents is not required.

This determination shall become effective upon its distribution by the Division and will be available on the Division’s website (<http://portal.ncdenr.org/web/wi/fonsi-dmca-ce>). This determination can be revoked at any time adverse information is made available. The documentation to support this decision will be on file with the North Carolina Department of Environment and Natural Resources, Division of Water Infrastructure, and is available for public scrutiny upon request.
