

Funding Actions Taken at the February 10, 2021 Meeting of the State Water Infrastructure Authority on the Applications Submitted in September 2020 to the Division of Water Infrastructure

On September 30, 2021, the Division of Water Infrastructure received applications for funding for drinking water, wastewater, asset inventory and assessment, and merger / regionalization feasibility projects. The available sources of funding for the September 2020 applications are:

1. Drinking Water State Revolving Fund ASADRA (DWSRF ASADRA)¹
2. Drinking Water State Revolving Fund (DWSRF)¹
3. Clean Water State Revolving Fund ASADRA (CWSRF ASADRA)
4. Clean Water State Revolving Fund
5. Drinking Water State Reserve²
6. Wastewater State Reserve²

Table 1 shows the amount of funding considered in applications that were complete and eligible and the approximate amount of funding available. On February 10, 2021, the State Water Infrastructure Authority determined the eligibility of applications selected to receive funding from the available funding sources listed above.

^dProjects funded with state funds for drinking water and wastewater projects, AIA grants, and MRF grants come from the State Reserve. \$10M of grant funds in the State Reserve may be used for MRF grants, AIA grants, drinking water projects, or wastewater projects. Up to \$1,120,000 of state drinking water grants may be used for drinking water construction projects. Up to \$629,000 of state wastewater grants may be used for wastewater construction projects. Up to \$22.1M of state wastewater loans may be used for wastewater construction projects.

¹ On June 6, 2019, the President signed P.L. 116-20, the “Additional Supplemental Appropriations for Disaster Relief Act, 2019: (ASADRA). The Act provided funding for resiliency-focused projects at drinking water facilities and wastewater treatment works impacted by Hurricanes Florence and Michael. NC Session Law 2019-250 appropriated the necessary State Match.

² State Reserve funds are utilized to fund construction projects, Asset Inventory and Assessment (AIA) grants, and Merger / Regionalization Feasibility (MRF) grants.

^eState reserve funding available is utilized for state reserve construction projects, AIA grants, and MRF grants. State reserve loan availability is \$22M only for drinking water and wastewater construction projects. State Reserve grant availability is \$11.7M and may be used for drinking water and wastewater construction projects, AIA grants, and MRF grants.
