Re: Proposed Readoption of Adult Day Care Services Rules – 10A NCAC 06Q
Proposed Readoption of Adult Day Care Standards for Certification – 10A NCAC 06R
Proposed Readoption of Adult Day Health Standards for Certification – 10A NCAC 06S
Proposed Readoption of State Adult Day Care Funding – 10A NCAC 06T

The North Carolina Department of Health & Human Services – Division of Aging & Adult Services (“DAAS”) proposes to readopt 37 rules from 10A NCAC 06Q, 06R, 06S and 06T pursuant to G.S. 150B-21.3A as part of the periodic rule review process. These proposed readopted rules pertain to adult day care programs. Substantive changes have been made to the proposed readoption rules through removal of outdated language, technical changes and incorporation of previously submitted comments.

The North Carolina Department of Health & Human Services submitted a Notice of Text form, 06Q, to the Codifier of Rules, Office of Administrative Hearings, and the Social Services Commission submitted a Notice of Text, 06R, 06S and 06T, to the Codifier of Rules, Office of Administrative Hearings, indicating the North Carolina Department of Health & Human Services intent to proceed with readopting the following rules:
