### 2018 Federal Government Shutdown

At the time of this writing, the federal government is experiencing a partial shutdown as President Trump and Congress negotiate a spending plan for 2018. The full impact of the shutdown on the military, veterans and their families is uncertain as of now. However please know that our offices across the state remain open and we are available to assist you and your family as much as possible.

## **VA Announces New Veterans Identification Card (VIC)**

The Dept. of Veterans Affairs (VA) has announced that it will provide national Veterans' Identification Cards (VIC) to veterans. The cards are now available for veterans who have provided honorable service to the nation. The new VIC will be a safe and convenient way for veterans to provide proof of service and no longer have to carry a paper DD-214. The VIC will allow honorably discharged veterans to obtain retail discounts as well as other services.

The card provides a convenient and secure alternative for those who served the minimum obligated time in service, but did not meet the retirement or medical discharge threshold.

To request a VIC visit [vets.gov](https://www.vets.gov), and click on "[Apply for Printed Veteran ID Card](#)". Veterans who apply for a card should receive it within 60 days of application.

## **Department of Defense, Homeland Security, and Veterans Affairs to Develop Mental Health Plan**

This month President Trump signed an [executive order](#) on "Supporting our Veterans during their Transition from Uniformed Service to Civilian Life."

The order mandates new mental health options for recently separated service members, aimed at helping prevent veterans' suicides, and requires the Departments of Defense, Veterans Affairs (VA) and Homeland Security to establish new plans for seamless mental health care for services members leaving the military and includes more outreach to at-risk veteran populations.

VA Secretary Dr. David Shulkin has identified suicide as a top clinical priority, noting that individuals who have left the military within a year are almost twice as likely to commit suicide.

The order will take effect on March 9, 2018, giving the departments 60 days to iron out details and develop plans.

GWG is charged with facilitating collaboration and coordination among federal, state, local, and non-profit partners who work with North Carolina's nearly 800,000 veterans and their families.
