<b>Taxes</b>	Prices do not include North Carolina sales or use tax.
<b>Order Placement</b>	Orders shall be placed through <a href="#">E-Procurement</a> using a procurement card. After logging in, use the <i>Search Bar</i> or <i>Tiles</i> to search for catalog items. When using the search bar, enter the desired search criteria ( <i>keyword, supplier part #, manufacturer, Statewide Term Contract ID (3121A), category</i> ) to get to the vendor punch-out catalogs.
