Contract Covers Provide and maintain a fuels credit card program for the purchase of gasoline, diesel and other designated motor fuels and oil at stations with extensive accessibility.

Financial Benefits:

WEX is currently paying a 1.60% volume rebate on all monthly transactions. As the aggregate spend on the contract increases, the volume rebate increases for all participants.
