



# NEW Statewide Term Contract

Effective Date: December 1, 2019 – November 30, 2022

## Third-Party Field Evaluation & Inspection Services – 961E

The Division of Purchase & Contract has established a new Statewide Term Contract to provide a source for Third-Party Field Evaluation and Inspection Services.

This is a mandatory contract for state agencies, departments, institutions, universities and community colleges, unless exempted by North Carolina General Statute. Non-mandatory entities, including schools and local governments, may use this contract if allowed by general statute.

### New Contract Highlights

This contract is intended to provide agencies with third-party field evaluation and inspection services in the specified categories, including cord & plug connected equipment and hardwired or permanently connected equipment types.

Inspections will be completed within ten (10) business days after a receipt of a purchase order. If a piece of equipment owned by a state agency failed an initial inspection, has been relocated, or has a need for reinspection based on other circumstances, the vendor shall charge a reinspection fee of 50.00% off the originally approved inspection fee.

There are four (4) tiers of discounts based on the county locations across the state. The discounts are applied to the total cost of the inspection. If a state entity requires inspections on multiple pieces of identical equipment, a 10 – 45 percent discount off the inspection fee is based on the number of items.

The vendor has a dedicated account manager for the efficient placement of orders, and to ensure that agencies receive the utmost level of customer service.

The Division of Purchase & Contract is focused on establishing Statewide Term Contracts that provide customers with goods and services at the best value.
