**COMMENTS:**

1. *White Goods disposal taxes are levied pursuant to Article 5C of Chapter 105 of the General Statutes , and G.S. 105-187.24 provides for a per capita distribution of the proceeds on a quarterly basis.*
2. *This report reflects collections for the months of January 2014 through March 2014.*
3. *Pursuant to S.L. 2013-360, Sections 14.17.(a) and 14.17.(i), effective August 1, 2013, the Secretary shall credit twenty-eight percent (28%) of the net tax proceeds to the General Fund.*
4. *Payments of the white goods disposal tax proceeds were withheld from those local governments that, per notification from the Secretary of the Department of Environment and Natural Resources, failed to comply with the requirements of G.S. 130A-309.09A(b), 130A-309.09A(d), and G.S. 130A-309.09(B)a, as amended by S.L. 2013-360 and S.L. 2013-409, and with G.S. 130A-309.87. The withheld white goods proceeds were credited to the General Fund.*
