5/18/2008 Smithfield Police Department	3-year-old Siraj M. Davenport was at the flea market with his alleged Mother when he was reported missing and possibly abducted.	Child was never at the Flea Market. This case was taken over by FBI and the results unknown. However, it was verified that the child was safe and flown in China to be with his biological father..
6/16/2008 Lexington County Sheriff Office, SC SLED	Robert W. Custer II, 45-year-old w/m, abducted his 4-year-old along with his Mother in Florida. The Mother escaped in Lexington, SC. Father and abducted child are possibly traveling to Maryland.	NC activated the AMBER Alert System on behalf of SLED. Mr. Custer was apprehended and the child has been recovered safely in Giles County, VA.
6/18/2008 Rockingham County Sheriff's Office	William Alexander Benitez, 17-year-old was forcibly abducted from his home by multiples individuals at knifepoint - possibly gang related. Believed to be taken to Texas.	6/24/2008 AMBER Alert was canceled subject located and is safe at Children's Center in Galveston, TX. 6/25/2008 York County Sheriff Office, SC SLED	11-month old Macey R. Sinclair was abducted by her father 27-yo Casey Sinclair, W/M. Mr. Sinclair abducted Macey in a drunken rage and left driving a vehicle.	NC activated on behalf of SLED. Father and child were located near Lake Wateree. Father was arrested, and Macey was safe and returned to her mother.

Brown, 43 y/o BM abducted 2-year-old Justice Rose Brown, from the parking lot of her daycare after eyewitnesses stated a verbal and physical assault with her mother took place biological father Joel k. Brown, 43, B/M. In violation of a court ordered restraining order. Joel Brown fled the State of Mass. The child has a life threatening medical condition, which he may be unaware. Multiple felony warrants are outstanding.</p>	<p>Mr. Brown left the state, drove to NY and after leaving NY entered the State of NJ, MD Washington, DC, VA, and NC where he has family and friends. Mr. Brown was order repeatedly via cell phone to surrender the child to the Smithfield PD, and he repeatedly refused.</p> <p>An AMBER Alert was issued at 2:00 am Friday morning 8/1/2008, Mr. Brown saw his picture on the morning news and he allegedly reported to Wayne County Sheriff Office and turned himself in on Friday August 1, 2008. He has been extricated to Mass.</p>
