I. Introduction

On March 10, 2020, the Governor of North Carolina, by issuing Executive Order No. 116, declared a state of emergency to coordinate a response and enact protective measures to help prevent the spread of COVID-19. (See <https://files.nc.gov/governor/documents/files/EO116-SOE-COVID-19.pdf>.) COVID-19 is a respiratory disease that can result in serious illness or death. COVID-19, previously unidentified in humans, spreads easily from person to person. Once an outbreak of COVID-19 begins, it is difficult to contain. The World Health Organization, the Center for Disease Control and Prevention, and the United States Department of Health and Human Services have declared COVID-19 a public health threat and emergency.

On March 12, 2020, the Governor of North Carolina and the NC Department of Health and Human Services recommended high-risk persons stay at home; that schools implement plans for distance or e-learning; that employers and employees use teleworking technologies; and that mass gatherings should cancel, postpone, and modify these events or offer online streaming services. On March 14, 2020, the Governor of North Carolina issued Executive Order No. 117 that prohibited mass gatherings, closed schools, and urged social distancing. (See <https://files.nc.gov/governor/documents/files/EO117-COVID-19-Prohibiting-Mass-Gathering-and-K12-School-Closure.pdf>.) As of June 17, 2020, approximately 46,855 North Carolinians have

tested positive for COVID-19 and approximately 1,168 North Carolinians have died since March 24, 2020. (See <https://covid19.ncdhhs.gov/dashboard>; <https://www.ncdhhs.gov/news/press-releases/north-carolina-reports-first-covid-19-associated-deaths>)

II. Petition for Rulemaking

As set forth in N.C. Gen. Stat. § 90-210.18A(a), the North Carolina General Assembly has declared that:

the practice of funeral service affects the public health, safety, and welfare and is subject to regulation and control in the public interest. The public interest requires that only qualified persons be permitted to practice funeral service in North Carolina and that the profession merit the confidence of the public.

To that end, the General Assembly created the North Carolina Board of Funeral Service (the “Petitioner” or the “Board”) to regulate the practice of funeral service in North Carolina. N.C. Gen. Stat. § 90-210.18A(b).

Individuals who wish to engage in the practice of funeral service in North Carolina must hold a license issued by the Board. The practice of funeral service includes caring, disinfecting, preparing (by embalming or otherwise) and disposing (by cremation or burial) of dead human bodies. N.C. Gen. Stat. § 90-210.20(j). Seven (7) of the nine (9) members of the Board hold either a funeral director license or a funeral service license.

The practice of funeral service often requires licensees to comply with rules relating to death care that are promulgated by other state agencies, such as the Commission of Public Health (the “Respondent”). As such, the Board strives to fulfill its statutory obligations by identifying possible amendments to such rules that would assist licensees to practice funeral service in a manner that better protects the public health, safety, and welfare.

Respondent is the public health rulemaking body for North Carolina that, among other things, promulgates rules to regulate epidemiology health in North Carolina. Pursuant to N.C. Gen. Stat. § 130A-29, Respondent is created with the authority and duty to adopt rules to protect and promote the public health.

Among the rules that Respondent has promulgated to implement its governmental mandates is 10A N.C.A.C 41A .0212 (the “Rule”), which provides as follows:

(a) It shall be the duty of the physician attending any person who dies and is known to be infected with HIV, plague, or hepatitis B or any person who dies and is known or reasonably suspected to be infected with smallpox, rabies, severe acute respiratory syndrome (SARS), or Jakob-Creutzfeldt to provide written notification to all individuals handling the body of the proper precautions to prevent infection. This written notification shall be provided to funeral service personnel at the time the body is removed from any hospital, nursing home, or other health care facility. When the patient dies in a location other than a health care facility, the attending physician shall notify the funeral service personnel verbally of the precautions required as soon as the physician becomes aware of the death. These precautions are noted in Paragraphs (b) and (c).

(b) The body of any person who died and is known or reasonably suspected to be infected with smallpox or severe acute respiratory syndrome (SARS) or any person who died and is known to be infected with plague shall not be embalmed. The body shall be enclosed in a strong, tightly sealed outer case which will prevent leakage or escape of odors as soon as possible after death and before the body is removed from the hospital room, home, building, or other premises where the death occurred. This case shall not be reopened except with the consent of the local health director. Nothing in this Paragraph shall prohibit cremation.

(c) Persons handling the body of any person who died and is known to be infected with HIV or hepatitis B or any person who died and is known or reasonably suspected to be infected with Jakob-Creutzfeldt or rabies shall be provided written notification to observe blood and body fluid precautions

N.C. Gen. Stat. § 130A-144 gives Respondent statutory authority to promulgate and amend the Rule. Respondent initially promulgated the Rule in 1988 and last amended the Rule in 2004 to include mandatory disclosures of SARS infection to funeral service workers. Respondent has not revised the Rule in 2020 to address the COVID-19 outbreak.

Respondent’s failure to amend the Rule to protect funeral service workers—and members of the public who they serve—against COVID-19 is perplexing. Without such regulatory reform, licensees are unable to practice their profession without jeopardizing their and the public’s health, safety, and welfare, as inadvertent transmission of this highly contagious disease is more likely if the funeral service workers are unaware of the decedent’s infection. According to the federal Occupational Safety and Health Administration, funeral service workers are classified within the “very high exposure risk” or “high exposure risk” to COVID infection, depending upon the nature of their contact with infected decedents. (*See <https://www.osha.gov/Publications/OSHA3993.pdf>*). Respondent’s failure to amend the Rule since the outbreak of COVID-19 is particularly troubling, as Petitioner has been informed by certain North Carolina hospitals that physicians will not disclose to funeral service providers whether a decedent is known or reasonably suspected to be infected with COVID-19, even upon the funeral service worker’s request.

Pursuant to N.C. Gen. Stat. § 150B-20, the Petitioner requests that Respondent grant and approve the Petition for Rulemaking and initiate rulemaking proceedings consistent with this Petition and pursuant to N.C. Gen. Stat. § 150B-20(c).

III. Documentation Submitted in Support of Petitioner’s Petition for Rulemaking

Petitioner submits the following information and documentation to comply with applicable statutory and regulatory requirements governing such petitions and requests:

- (1) a draft of the proposed rule change (which is incorporated by reference herein and attached as “Exhibit A”);
- (2) the statutory authority for the agency to make the proposed rule change;
- (3) a statement of the reasons for the proposed rule change;
- (4) a statement of the effect of the proposed rule change on existing rules and statutes;
- (5) any data supporting the proposal;

- (6) the effect of the proposed rule change on existing practices in the area involved, including cost factors;
- (7) the names and addresses of those most likely to be affected by the proposed rule (which is incorporated by reference herein and attached as “Exhibit B”); and
- (8) the name and addresses of the Petitioner

IV. Reasons for Adoption of the Proposed Rule

Respondent’s mandate is to protect the public health of North Carolinians through its rule-making. The proposed Rule amendment would allow Respondent to meet that goal. A survey of surrounding states shows that the laws of Virginia, Tennessee, and South Carolina currently require such disclosures to funeral service workers who take possession of a decedent who was infected or likely was infected with COVID-19 at the time of death. For example, Virginia provides as follows:

Upon transferring custody of any dead body to any person practicing funeral services or his agent, any hospital, nursing facility or nursing home, assisted living facility, or correctional facility shall, at the time of transfer, notify the person practicing funeral services or his agent if the individual was known to have had immediately prior to death an infectious disease which may be transmitted through exposure to any bodily fluids.

Va. Code Ann. § 32.1-27.1 (2020). Tennessee provides as follows:

Whenever any physician, surgeon or practitioner of medicine knows or suspects that any person whom the physician, surgeon or practitioner of medicine has been called to visit, or who has been brought to the physician, surgeon or practitioner of medicine for examination, or any other suspicious information received relative thereto, is infected, or even so suspected, with any communicable disease, except venereal disease, such physician, surgeon or practitioner of medicine shall immediately notify the health authorities of the town or county in which the diseased person or persons are found. In the event of the death of such person, the physician, surgeon or practitioner of medicine shall also notify, or cause to be notified, at the time of delivery, the person to whom the body is delivered of the known or suspected communicable, contagious or infectious disease, including acquired immune deficiency syndrome (AIDS), so that the necessary and proper precautions can be taken in the handling, preparation for disposition or disposition of the body.

Tenn. Code Ann. § 68-5-102 (2020). South Carolina provides as follows:

Upon declaration of a Public Health Emergency, DHEC will notify coroners, medical examiners, and funeral directors of specific procedures to be followed in handling and disposing of remains of individuals known or presumed to have died from or been exposed to contamination or communicable disease. This may include individuals determined to have died as a result of other causes, such as trauma, but who had been exposed prior to death.

S.C. Code Regs. 61-112.

In light of the unprecedented pandemic impacting all North Carolinians, amendments to the Rule will help protect the health, safety and welfare of all North Carolinians who are putting their lives at risk to honor the dead and to help vulnerable families grieve for their loved ones.

V. Statement of the Effect of the Proposed Rule on Existing Rules, Statutes and Practices

The proposed amendments to the Rule would have no effect on other existing rules or statutes. In particular, the proposed rule change will conform with existing federal regulation related to HIPAA, which provides that “[a] covered entity may disclose protected health information to funeral directors, consistent with applicable law, as necessary to carry out their duties with respect to the decedent. If necessary for funeral directors to carry out their duties, the covered entity may disclose the protected health information prior to, and in reasonable anticipation of, the individual's death.” (45 CFR § 164.512(g)(2))

Petitioner strongly believes that the proposed amendments would maintain the intent of the existing Rule to slow and prevent the spread of highly infectious disease. The proposed amendments should not require any significant deviation in the way healthcare workers currently inform funeral service personnel that a decedent may be infected by a disease identified in the existing Rule. The proposed amendments should not require any significant additional costs to

the regulated public, given that disclosure of other infectious diseases already is mandated under the existing Rule.

VI. Name and Address of the Petitioner and Those Most Likely to be Affected by the Proposed Rule

The Petitioner is the North Carolina Board of Funeral Service, whose office is located at 1033 Wade Ave, Suite 108, Raleigh, NC 27605.

Additionally, the names and addresses of all currently licensed funeral establishments, which employs those most likely to be affected by the proposed amendments in North Carolina, are attached as Exhibit B.



Proposed amendments are highlighted and underlined:

10 NCAC 41A .0212

(a) It shall be the duty of the physician attending any person who dies and is known to be infected with HIV, plague, or hepatitis B or any person who dies and is known or reasonably suspected to be infected with an infectious disease which may be transmitted through exposure to any bodily fluids, such as smallpox, rabies, severe acute respiratory syndrome (SARS), COVID-19, or Jakob-Creutzfeldt to provide written notification to all individuals handling the body of the proper precautions to prevent infection. This written notification shall be provided to funeral service personnel at the time the body is removed from any hospital, nursing home, or other health care facility.
