3 **21 NCAC 16A .0106 PETITION FOR PREDETERMINATION**

5 An individual who wishes to file a petition for a predetermination of whether the individual's criminal history will  
6 likely disqualify the individual from obtaining a dental license or dental hygiene license shall submit a petition on the  
7 forms furnished by the Board at [www.ncdentalboard.org](http://www.ncdentalboard.org) that shall include the petitioner's:

- 8 (1) legal name;
- 9 (2) mailing, physical, and email addresses;
- 10 (3) social security number;
- 11 (4) date of birth;
- 12 (5) telephone number;
- 13 (6) places of residence for the past seven years;
- 14 (7) employment history since the commission of the crime(s);
- 15 (8) criminal record report prepared no more than 60 days prior to the date of petition by Castle Branch,  
16 Inc., or another reporting service designated by the Board in accordance with G.S. 93B-8.1(b6), the  
17 cost of which shall be borne by the petitioner;
- 18 (9) copies of all documents in the court file related to any conviction reported on the petition or noted  
19 on the criminal record report, which copies shall be certified by the clerk of court or other judicial  
20 official;
- 21 (10) written statement describing the circumstances surrounding the commission of the crimes;
- 22 (11) written statement of any rehabilitation efforts, if applicable;
- 23 (12) rehabilitative drug or alcohol treatments, if applicable;
- 24 (13) Certificate of Relief granted pursuant to G.S. 15A-173.2, if applicable;
- 25 (14) affidavits or other written documents, including character references, that the petitioner wishes the  
26 Board to consider in responding to the petition;
- 27 (15) written statement certifying that the information and documentation submitted with the petition is  
28 complete and accurate to the best of the petitioner's knowledge;
- 29 (16) fee of forty-five dollars (\$45.00) for a petition for predetermination; and
- 30 (17) notarized signature.
