The State Board of Education approved the withdrawal of the following rules at their meeting on November 5, 2020:

- **16 NCAC 06B .0113 Activity Bus Drivers**
Unnecessary because DMV and federal law govern.
- **16 NCAC 06D .0211 Textbook Evaluation Criteria and Invitation to Submit**
Unnecessary internal management policy.
- **16 NCAC 06G .0503 Charter School Accountability Requirements**
Subsumed into 116 NCAC 6D. 0315 by expanding the testing obligations of LEAs to include all PSUs, including charter schools.
- **16 NCAC 06G .0316 Purpose and Composition of the State Board of Education's Compliance Commission for Accountability**
Unnecessary internal management policy.
