**Singletary Lake State Park Group Camp Fee and Deposit Schedule**

**Camp Ipecac** (84-person maximum capacity) – Open April 1<sup>st</sup> – October 31<sup>st</sup>  
\$110.00 per night / \$425.00 per week (see Facility Guidelines for specific check-in days)  
Weekly rental only during the months of June, July & August

**Camp Loblolly Bay** (48-person maximum capacity) – Open year-round except Christmas Day  
\$110.00 per night / \$425.00 per week (see Facility Guidelines for specific check-in days)  
Weekly rental only during the months of June, July & August

**Educational Building** (30-person maximum capacity) – Open year-round except Christmas Day  
\$78.00 per day (Available use during the hours of 8 a.m. to 5 p.m. only)

**Deposit Calculation**

Deposits are per facility. All applications must have a deposit included or it will not be processed. Deposits equal half of the total amount of your stay. The remaining balance will be collected at check-out.

**Examples for Calculating Deposit**

1 Night Ipecac **or** Loblolly Bay  
\$110.00 divided by 2= \$55.00

2 Nights Ipecac **or** Loblolly Bay  
\$220.00 divided by 2= \$110.00

1 Night Ipecac **and** Loblolly Bay  
\$220.00 divided by 2 = \$110.00

2 Nights Ipecac **and** Loblolly Bay  
\$440.00 divided by 2= \$220.00

Weekly Ipecac **or** Loblolly Bay  
\$425.00 divided by 2 = \$212.50

Weekly Ipecac **and** Loblolly Bay  
\$850.00 divided by 2= \$425.00

1 Day Education Building  
\$78.00 divided by 2 = \$39.00

SINGLETARY LAKE STATE PARK  
**GROUP CAMP FACILITY GUIDELINES**

ATTN: GROUP LEADERS

It is your responsibility to discuss the following information with group campers BEFORE arrival at Singletary Lake Group Camp Facility.

You or an appointed person from your group must check-in at the office before 5:00 p.m. to receive a key for the camp facility access. No afterhours check-in is available.

Camp Ipecac has a sleeping capacity of (84 persons). Camp Loblolly Bay has a sleeping capacity of (48 persons). Campers must sleep in the cabins only. By the order of the Bladen County Fire Marshal, these capacities **MUST** not be exceeded. Tent camping is not allowed. Recreational vehicles (RV's) are not allowed except when self-contained and registered with the park office. Connection to park utilities is prohibited.

At check-in, park staff will issue you a key to open the entrance gate to the group camps. This same key will also open the group camp facility you have reserved. You should inform all group members that you have this key. Gates will be open from 8:00 a.m. to 5:00 p.m. daily. If members of your group arrive after 5:00 p.m. or depart prior to 8:00 a.m., it will be your responsibility to give them access through the camp entrance gate. Park quiet hours are from 10:00 p.m. to 7:00 a.m. daily. During quiet hours, activities should be limited to the immediate area of the group camp facility occupied. Vehicle traffic should be kept to a minimum during quiet hours.

During weekly rentals, groups may check in Sunday mornings after 8:00 a.m. Check out is Saturday before 3:00 p.m. These days and times are strictly enforced.

At check-out, your group camp facility will be inspected per instructions posted in each building. Failure to satisfactorily clean your facility will result in a clean-up fee being charged and forfeiture of future camping at Singletary Lake Group Camp. Please use bleach based products to ensure cleanliness.

Inspection at departure takes approximately 35-45 minutes per camp. Inspection must be completed by 3:00 p.m. Please notify park staff at check-in of what time you wish to check out. All campers must vacate the camp premises by 3:00 p.m.

Do not screw or nail objects, signs, emblems, etc. to structures including gates and piers.

No parking in Fire Lane. Violations will be cited.

Alcoholic beverages, firearms (non-permitted) and fireworks are prohibited in all State Parks and State Recreation Areas.

Pets are not allowed in cabins, mess halls, education building and washhouses unless they are certified aid animals. While on the park, all pets must be attended on a leash no longer than six feet.

All-terrain vehicles, golf carts and off-road driving is prohibited in State Parks. Motorized wheelchairs are permitted for those with disabilities.

Portable/window air condition units and space heaters are not allowed in any camp buildings.

A recycling bin is provided in each camp's mess hall for recyclables. Aluminum cans **MUST** be recycled. Singletary Lake State Park's swimming season is from April 1- October 31. Please refer to the swimming guidelines. Please be considerate of park wildlife. Observe wildlife; do not disturb.
